Includes detached pages (3 scans) of a Bible record kept by Cornelius Clopper (b. 1735) and descendants; handwritten transcripts of this and other Bible records (15 scans) copied into the "Common Place Book" of Edward N. Clopper (b. 1840) by his father, Joseph Chambers Clopper (b. 1802); a death notice (1 scan) for Oliver Mortimer Clopper (d. 1878); and accounts (9 scans) by Joseph Chambers Clopper of the deaths of two of his sisters, Rebecca C. ## English Village Corporation (Richmond, Va.). .45 cubic feet.

Records, 1927–1952, of the English Village Corporation of Richmond, Virginia, containing correspondence regarding board of directors' and stockholders' meetings, complaints, elections of officers, lease renewals and sales of units, legal proceedings, maintenance and landscaping, operating expenses, parking, resolutions, taxes and assessments, tenants and property owners' rules and regulations, and other matters. Records, 1865–1896, of H. Seldon Taylor and Son of Richmond, Virginia, real estate agents and auctioneers, including a sales book and two indexes. The records also include sales made by its predecessor company, James M. Taylor and Son. The sales book contains entries for property sales which include type of sale, seller and purchaser names, location and size of property, sale price, and terms. Discharge papers, 1864 and 1865, for Charles E. Anderson (b. 1843) of Captain Elias Powell's Company (K), 7th Regiment of West Virginia Cavalry. Gift of Joe Workman, Powhatan. (51016)

## Bell, Miller G. 7 pages.

Letter, 3 May 1864, from Miller G. Bell (ca. 1841–1880), Company E, 3rd New Jersey Cavalry, in Washington, D.C., to his mother, Rebecca T. Bell (b. ca. 1815) of Hunterdon County, New Jersey, sending news about himself and the regiment, including news of family and friends; discussing military life, including having to have his horse shot, and being a body guard for General Ambrose Burnside; and speculating on his company's next movements. Purchased. (50833)

### Bond, Herbert George. 43 pages.

Letters, 1862–1863, from Herbert George Bond (1846–1928), Company I, 16th Vermont Infantry, to his brother Leavitt E. Bond (1837–1921) and his sister-in-law, Julia F. Pierce Bond (1838–1921) of Dummerston, Windham County, Vermont, describing camp life, drilling, rations, and picket duty. Bond describes the Virginia countryside, including a description of the Fairfax County court house. He mentions Generals Ambrose Burnside and E. H. Stoughton (1838–1868), as well the Confederate army. He also mentions the troops playing baseball. Purchased. (51186)

#### **Buckley, Edith Francisco.** 8.3 cubic feet.

Papers, 1908–2013, of Edith Francisco Buckley of Fairfax, Virginia, concerning her ancestor Peter Francisco (1760–1831) and the Society of the Descendants of Peter Francisco. Collection documents Buckley's and the Society's efforts to discover and record Francisco's life and Revolutionary War service, as well as to trace his descendants. ## Cunningham, C. N. W. 1 leaf.

Letter, 15 August 1863, from Sergeant C. N. W. Cunningham (ca. 1843–1893), Company A, 13th Massachusetts Infantry, stating that [Michael A.] Fitzgerald (b. ca. 1841) had been captured at the battle of Gettysburg and was now in Richmond, Virginia, as a prisoner of war. Fitzgerald's real name was Augustine B. Haynes. Purchased. (51184)

## Edmonds, John Creegan. .875 cubic feet.

Papers, 1940–1980 and undated (bulk 1940–1950), of Lieutenant John Creegan Edmonds (1923–2002) consist of letters written from Edmonds to his future wife, Bette Kremer (1920–), while training and serving as a U. S. Navy pilot during World War II; his flight log, December 1942–April 1946; Edmonds' ground school navigation workbook kept while at the U.S.N. Air Training Center in Pensacola, Florida, 1943; three training manuals; a small diary, 10 October–25 November [1944?] with brief notations on various bombing missions in which Edmonds participated as part of Bombing Squadron Seven, attached to the U.S.S. Hancock in the Philippines and South China Coast region; a "squadron narrative" for Bombing Squadron Seven; a group photograph from a 1978 reunion of U.S.S. Hancock shipmates; and other assorted papers related to his service. Gift of Peter Edmonds, Maidens. (51040)

#### Eubank, Edward N. .45 cubic feet.

Papers, 1877–1932, of Edward N. Eubank (1853–1946) of Newport News, Virginia, relating to his involvement in the Virginia Volunteers, including a clothing account book of the Lynchburg Home Guard, accounts, receipts, and an officers' roster of the Huntington Rifles, manuals on the use and regulations of small arms and rifles, and legislation in the Virginia General Assembly concerning the retirement of officers. The collection also contains Eubank's notes on the organization of Confederate units from Alabama, and numerous publications. #### Ford-Taylor Family. .45 cubic feet.

Papers, 1855–1930, of the Ford and Taylor families of Chesterfield and Cumberland Counties, Virginia. The bulk of the collection is comprised of correspondence, covering the years 1863 to 1868, between Samuel A. Ford (1846–1930) and Mary Maria Taylor (1844–1902) prior to their marriage. Some of the letters were written by Ford while he was serving with the 3rd Virginia Cavalry. There are also genealogical notes and photographs. Gift of Samuel Ford Harahan, Reston. (51160)

#### Gilkeson, William J. 3 pages.

Deed, dated 11 December 1858 and recorded 14 December 1858, for 45 acres in Augusta County, Virginia, from Alexander Paris and Sarah C. Paris, both of Albemarle County, Virginia, to William J. Gilkeson (ca. 1790–1866) of Augusta County. Purchased. (50682)

#### Greene, Ezra. 8 pages.

Letters, 1861–1862, of Ezra Greene (1838–1889) of Company H, 2nd Rhode Island Infantry, consisting of a letter, 15 August 1861, to his brother George C. Greene (1840–1911) of Kent County, Rhode Island, describing the difficulties of picket duty; construction of breastworks to protect Washington from Confederate attack; and complaints about rations and cooking his own food; and a letter, 14 December 1862, from A. E. Smith of Saratoga, Minnesota, to Greene containing news of mutual friends in Minnesota, Rhode Island, and the army; stating that he misses Rhode Island; commenting on Minnesota; and asking about the war, including about General Ambrose Burnside. #### **Henderson, James A.** 2 pages.

Letter, 10 January 1862, from James A. Henderson (b. ca. 1837), Company E, 5th Alabama Infantry, in Prince William County, Virginia, to his sister Malissa A. Henderson (b. ca. 1844) of Belmont, Sumter County, Alabama, writing about his health, his company and its health; mentioning he is near the Manassas battlefield and how cold it is; and providing news of relatives and friends, including a death. Purchased. (51182)

#### Hicks, F. Y. 1 leaf.

Letter, 18 July 1862, from F. Y. Hicks (1838–1912), Company D, 15th North Carolina Infantry, near Richmond, Virginia, to his father, Durham Hicks (b. ca. 1803), Cleveland County, North Carolina, informing them that the Union army is unlikely to advance on Richmond again; that the North Carolina regiments are awaiting the arrival of conscripts; and that he has written many letters home, but hasn't heard from home. #### Howland, Harrison G. 2.4 cubic feet.

Papers, 1794–1966, of Harrison G. Howland (1812–1883) of King George County, Virginia, including accounts and receipts, accounts of sales, agreements and contracts, bonds and promissory notes, circulars, clippings, correspondence, deeds, estate papers, genealogy, slave records, surveys, tax tickets and receipts, and warrants. A microfilm copy of this collection is available as Accession 50425 (Misc. Reels 6117–6122). Gift of Bruce G. Cartwright, Alexandria. (51176)

#### **Kent, Samuel S.** .1 cubic feet.

Papers, 1845–1867, of Samuel S. Kent (1820–1904) of Halifax County, Virginia, containing accounts and receipts, a letter, summonses, and records relating to the estates of Elizabeth Anderson (1790–1875), Mary Coates (d. 1858), and Stephen Kent (1777–1861). Gift of Alexandra Gressitt, Leesburg. (51199)

#### McCarley, John J. 3 pages.

Letter, 20 November 1862, from John J. McCarley, Company A, 19th Georgia Infantry, to Jessee Chambers in Georgia, written shortly after McCarley was exchanged as a prisoner. McCarley writes that he hopes his uniform and possessions were sent with the company when it left Warrenton, Virginia. He provides news of friends in the army

and asks for news about friends at home. He recommends that Chambers, who is probably serving in a state guard unit, remain at home. Purchased. (50842)

## **McCarthy, Lynn C.** 8 leaves and 8 photographs.

Information, compiled by Lynn C. McCarthy in 2014, about the burial location of Mildred Ruffin Sayre (d. 1862), in the Sayre-Rodman plot in Frankfort Cemetery, Frankfort, Kentucky. Includes biographical information on the family, as well as physical descriptions, drawings, photographs, and transcripts of the tombstones in the plot. Gift of Lynn C. McCarthy, Frankfort, Kentucky. #### Millner, Thomas B. 2 pages.

Petition, 17 March 1862, of Thomas B. Millner (ca. 1837–1898) of Bedford County, Virginia, to the Bedford County Board of Exemptions asking to be exempt from military duty due to having a deformed chest and already being rejected from the volunteer service. Reverse contains a note from Robert A. Clement, M.D., and H. W. Moseley stating that Millner has contracted chest and heart disease. Purchased. (51183)

## Monk, Arliss Shaffer. .9 cubic feet.

Papers, 1973–2011, of Arliss Shaffer Monk (1921–2013) of Greeley, Colorado, containing genealogical research on the Barkham, Corbin, Eltonhead, Ijams, Jenings, Philips, and Waters families of Lancaster, Loudoun, Middlesex, and York Counties, Virginia, and Maryland and England. The collection includes correspondence and research notes, and abstracts, copies, and transcriptions of census records, church records, court records, deeds, estate administration records, tax records, tombstone inscriptions, vital statistics, and wills. There are also guidebooks to Bruton Parish churchyard in Williamsburg, Virginia, and Ripon Cathedral in North Yorkshire, England. Gift of Arliss S. Monk, Greeley, Colorado. (50374)

#### Rucker, Ambrose B. 1 leaf.

Letter, 9 January 1861, from Ambrose B. Rucker (1813–1872) of Lynchburg, Virginia, to John B. Cabell (ca. 1802–1883) of Greenbrier County, (West) Virginia, informing Cabell that he had collected the last payment from Fretwell and Hall for the property they purchased from Cabell; commenting on the poor weather in Lynchburg; and worrying over national politics. Purchased. (51076)

#### Schwartz, Bernard A. 1 CD (30.8 MB).

Miscellaneous information about Northumberland County, Virginia, compiled by Bernard A. Schwartz in 2010, and including spreadsheets with transcripts and surname indexes of Northumberland County order books (1759–1762 and 1762–1766); an index to the names and places in the *Bulletin of the Historical Society of Northumberland County* (Vols. 1–46); a file of names and properties appearing in the Northumberland County land grants listed in *Cavaliers and Pioneers* (Vols. 1, 2); and a spreadsheet summary index of 24 books related to Northumberland County, some of which were not indexed originally. ## **Tyler, James Hoge.** 2 volumes and 2 CDs.

Collection, compiled in 2010, of two volumes pertaining to James Hoge Tyler (1846–1925), who served as governor of Virginia from 1898 to 1902. The first is a transcript of Tyler's diary, 1879–1924, which opens with a genealogy that Tyler recorded for his children, with information on his own ancestry and that of his wife, Sue Hammet Tyler (1845–1927), including Craig, Hammet, Hoge, Montgomery, and Tyler lines. The diary continues with semi-regular updates on the family, and includes several entries from Sue Hammet Tyler during her husband's term as governor; transcriptions of various papers, 1833–1843, of the governor's mother, Eliza Hoge Tyler (d. 1846); and poems and other writings by his daughter, Eliza (Lily) Tyler (b. 1882). The second volume is a copy of a University of Virginia doctoral dissertation, "The Life and Political Career of J. Hoge Tyler, Governor of Virginia, 1898–1902," written by Thomas Edward Gay, Jr. in 1969. Gift of Harrison M. Wilson, Locust Valley, New York. (51209)

## **Vollertsen, Dorothy Fox.** 7.5 cubic feet.

Papers, 1968–2001, of Dorothy Fox Vollertsen (1910–2007) of Williamsburg, Virginia, containing genealogical research for her admission, and that of her husband, Dr. Arthur H. Vollertsen (1910–1983), to various hereditary and patriotic organizations. The collection also includes materials documenting her involvement with the groups, lineage research assistance she provided to other individuals seeking admission, and numerous records submitted to the genealogical records committee of the Virginia Daughters of the American Revolution.
