Virginia Insurance Company (Staunton, Va.). .45 cubic feet.

Records, 1869-1872, of the Virginia Insurance Company consist of individual's application for insurance policies. Insurance policies contain the name and age of insured, as well as the date and premium of the insurance policy. Applications also contain questionnaires regarding personal information of the applicants, including name of their spouse, current residence and occupation, vaccinations they have received, and the health history of themselves and their immediate family. In addition, applications include two questionnaires to be completed by a personal reference and the physician regarding the "general health and habits of life" of the applicant. ORGANIZATION RECORDS

Covington Sunday School (Alleghany County, Va.). 1 volume.

Death records include the name of deceased, as well as the location and date of their death. Collection also includes death claim receipts, as well as some correspondence. Correspondence includes that of beneficiaries to the Office of the Juvenile Department of the Order of St. Luke, as well as some internal correspondence
