Barron, Jane A. 4 pages.

Letter, 16 June 1815, from Jane A. Barron (1791-1862) of Hampton, Virginia, to Dolley Madison (1768-1849), wife of President James Madison (1751-1836), asking for a consular post for her father, Commodore James Barron (1768-1851), who had been stranded in Europe because of the War of 1812 while suspended from active Naval service. Purchased. (52545)

Land grant, 5 April 1755, for 310 acres located in that part of Frederick County, Virginia, that became Berkeley County, West Virginia, from Thomas, Lord Fairfax (1693-1781), proprietor of the Northern Neck, to John Bozeoth of Frederick County. Lent for copying by John Gold, Montross. (52617)

Leppien, George F. 9 pages.

Report, 8 October 1862, of Captain George F. Leppien (1836-1863), commanding the 5th Maine Battery, to Major Davis Fillson, chief of artillery, 3rd Corps, on the battles of Rappahannock Station and 2nd Bull Run, including the battery's movements from 20 August to 2 September and a list of the battery's killed and wounded.
