Quarterly Report of Newly Processed Collections July–December 2011

Welcome to the latest issue of the Library of Virginia's quarterly report *Primary Sources*. Here you will find a listing of the latest collections processed, microfilmed, or digitized by the Library. Since 1999, the Library has annually received General Assembly support for archival positions in order "to relieve the 54-year backlog in processing significant archival, special, and other historical collections."

LOCAL RECORDS

The Local Records Services Branch is charged with preserving, cataloging, and providing access to the records that document the daily activities of Virginia's counties, towns, and independent cities. The branch administers the Circuit Court Records Preservation Program (CCRP), which provides grant funds to the Commonwealth's 120 circuit court clerks to help preserve the historically valuable records maintained in their offices and those that have been transferred to the Library of Virginia for archival processing and storage.

Since 2007, the Virginia Circuit Court Records Program (CCRP) has scanned and posted images of original chancery causes for 52 localities totaling more than 5.9 million images. Over the past two quarters the Library added scanned chancery causes for two localities totaling 614,911 images.
