Chandler Family. 4 leaves.

Bland and Elizabeth City Counties, Virginia, 1901–1987. Bible of Lester Norman Chandler (d. 1944) and Nina Jane Chandler (d. 1970). Includes Bible records (3 leaves) and a typed transcript (1 leaf) of the Marriages page of the Bible (the original is not included). Other surnames mentioned: Dillion, Drummond, Hayes, Martin, Morrison, Simpson, Taylor, Viar, Wilson, and Wright. Gift of Jacqueline C. Cahoon, Stuarts Draft. (50245)

Drummond Family. 7 leaves.

Accomack and Elizabeth City Counties and Hampton, Virginia, 1755–1826. Thought to be the Bible of Rachel Drummond. Bible printed in 1750. Includes Bible records (3 leaves), transcript (1 leaf) and family group sheets (2 leaves) provided by the donor, and a photograph (1 leaf) of a sampler stitched by Alice Wade Drummond. Gift of Jacqueline C. Cahoon, Stuarts Draft. (50243)

Dunn Family. 5 leaves.

Elizabeth City and York Counties, and Hampton, Virginia, 1869–1904. Bible of Fred H. Dunn (d. 1889) and Martha A. Wade Dunn (d. 1893). Bible printed in 1886. Other surnames mentioned: Powell, Smith, and Wade. Gift of Jean von Schilling, Richmond. (50196)

French Family. 14 leaves.

Cumberland and Powhatan Counties, and Richmond, Virginia, 1813–1889. Bible of John W. French (1813–1883) and Judith F. Blanton French (b. 1825). Bible printed in 1856. Includes Bible records (5 leaves) and enclosures (9 leaves), chiefly consisting of obituaries and pedigree charts. Other surnames mentioned: Blanton, Cadwell, Crane, Dabney, Harwood, Leber, and Madison. Surnames appearing in the obituaries and pedigree charts include: Jones, Nuckols, Webb, Wiltshire, and Windisch. Loaned for copying by Ed Miller, Richmond. (50198)

Golladay Family. 5 leaves.

Shenandoah County, Virginia, 1809–1898. Bible of Samuel Golladay (b. 1809) and Deliah McInturff Golladay (1817–1898). Other surnames mentioned: McInturff and Munch. Gift of Robert Howell, Lynchburg. (50173)

Harris Family. 8 leaves.

Middlesex County, Virginia, 1870–1930. Bible of David H. Harris (d. 1896) and Nancy Ann Henry Harris (d. 1919). Includes a photograph of an unidentified group of people, presumed to be family members. Other surnames mentioned include: Brooks, Carter, Henry, Robinson, Smith, Tabb, and Watkins. Loaned for duplication by Davaline Taliaferro Beslow, Deltaville. (50191)

Humes Family. 4 leaves.

Rockingham County, Virginia; and Ohio, 1827–1949. Bible of James Addison Humes (1827–1883) and Marietta Johnson Humes (1833–1899). Bible printed in 1867. At times in the record the name is spelled “Hume.” Other surname mentioned: Johnson. Gift of Demarius A. Austin, Lima, Ohio. (50111)

Humes Family. 5 leaves

Rockingham County, Virginia; and Ohio, 1859–1978. Bible of James W. Humes (1859–1949) and Susanna Donavon Humes (b. 1864). Bible printed in 1882. Other surnames mentioned: Baker, Burning, Donavon, Grassnickle, Hoff, Howard, Joseph, King, O’Dell, Smith, and Stooky. Gift of Demarius A. Austin, Lima, Ohio. (50110)

Lyne Family. 7 leaves.

Orange County and Richmond, Virginia, 1868–1910. Bible of William Henry Lyne (1843–1887) and Cassie Oliver Moncure Lyne (1845–1934). Includes Bible records (3 leaves) and enclosures (4 leaves). Other surnames mentioned: Moncure, Randolph, Ryland, Shackelford, and White. Enclosures include tributes related to the death of Dr. William H. Lyne (1873–1905), and a wedding announcement for Lucy Lawrence Lyne (b. 1894) and Robert Carroll Slaughter. Gift of David Lyne, Warrenton. (44239)

Mears-Drummond Family. 27 leaves.

Elizabeth City County and Chesapeake and Hampton, Virginia; and California, 1837–1982. Bible of Marion Colbert Drummond (1876–1930) and Rhoda Mears Drummond Wallace (1888–1958). Includes Bible records (7 leaves) and other papers (20 leaves), chiefly consisting of obituaries and several condolence notes regarding the death of Marion Colbert Drummond. Other surnames mentioned include: Abbott, Beatty, Boschma, Cahoon, Chandler, Clifton, Davis, Delp, Hornback, Klor, Lambert, Mallison, Ross, Tohm, Wallace, and Wren. Gift of Jacqueline C. Nuckols Family. 8 leaves.

Hanover County and Richmond, Virginia, 1864–1976. Bible of Rosa W. French Nuckols (1876–1906). Bible printed in 1892. Includes Bible records (6 leaves) and a photograph with “Bill Nuckols” written on the reverse (2 leaves). This is likely William A. Nuckols (1864–1909), husband of Rosa Nuckols. Other surnames mentioned: French and Johnston. Loaned for copying by Ed Miller, Richmond. (50197)

Redd Family. 3 leaves.

Caroline and King and Queen Counties, Virginia, 1806–1885. Family record of William Lewis Redd (1846–1902) and Mary Adaline Wyatt Redd (1850–1900). Record is a notebook with family dates and other notations. Other surnames mentioned: Davies, Garrett, Gibson, and Wyatt. Loaned for duplication by Barbara B. Payne, Urbanna. (50193)

Redd Family. 9 leaves.

King and Queen, and Middlesex Counties, Virginia, 1846–1978. Bible of William Lewis Redd (1846–1902) and Mary Adaline Wyatt Redd (1850–1900). Other surnames mentioned: Blake, Bourne, Durham, Gardner, Thrift, Williams, and Wood. Loaned for duplication by Barbara B. Payne, Urbanna. (50192)

Seagar-Seagers-Manders Family. 6 leaves.

Richmond, Virginia, 1823–1889. Bible of John Seagar and Martha Walsh Seagar (d. 1840). Bible printed in 1825. Other surnames mentioned: Sheen(?) and Walsh. Transferred from Technical Services, Library of Virginia, Richmond. (50076)

Whitehurst Family. 13 leaves.

Princess Anne County, and Norfolk, Virginia; and California, 1816–1985. Bible of Edward H. Whitehurst (1851–1933). Bible printed in 1881. Other surnames mentioned: Bain, Bondro, Craft, Gayle, Jackson, Lawson, McClanhan (also spelled McClennan), Norvell, Petree, Spence, Williamson, and Young. Gift of Gayle N. Mandell, Norfolk. (50074)

Young Family. 9 leaves.

Norfolk, Portsmouth, and Richmond, Virginia, 1755–1982. Bible of Joseph Laville Young (b. 1834) and Carrie Elethia Richardson Young (1838–1910). Other surnames mentioned: Barker, Bernard, Brown, Burrows, Chowning, Cole, Dale, Gayle, James, Jones, Mandell, McClanhan, Morrisette, Norvell, Richardson, Shumaker (also spelled Shoemaker), Stallworth, Whitehurst, and Wise. Records, 1857–1910, of Ephraim Baker (1836–1918) of Mount Olive, Shenandoah County, Virginia, relating to his operation of a general store, and his partnership in the firm Baker, Eberly and Company. Includes accounts, correspondence, customer orders, circulars, price lists, and photographs. The bulk of the records date from 1867 to 1883. Purchased. (50152)

Business records, 1891–1893, of Charles Danne (1844–1932) of Louisa County, Virginia, consisting of accounts, invoices, letters, and receipts detailing Danne's business dealings with Richmond, Virginia, companies for supplying his general store located in Trevilians, Louisa County, Virginia. Letter, 29 January 1862, from Kent, Paine, and Company, a dry-goods and clothing manufacturer in Richmond, Virginia, to Captain Hugh M. Nelson (1811–1862) of the 6th Virginia Cavalry Regiment regarding payment of an account relating to buttons. Purchased. (45502)

Moore, R. O. .1 cubic foot.

Business records, 1904–1915, 1925, of R. O. Moore (1858–1936) of Cumberland County, Virginia, consisting of accounts, bills of lading, envelopes, invoices, letters, post cards, and other papers detailing Moore's business dealings with Richmond, Virginia, companies for supplying his general store located in Clinton, then Sunnyside, Virginia. Purchased. (44469)

Democratic tickets, 6 November 1860, listing the Virginia electors for the Democratic Party candidates John C. Breckinridge (for president) and Joseph Lane (for vice president). Ticket lists electors for each district. The back of one ticket is signed Joseph N. Johnson and the other is signed Warren Webb. Donor information unavailable. (50121)

Banton, Alexander. 10 p.

Papers, 1942–1945, 1987, of Alexander Banton (1921–1987) of Buckingham County, Virginia, chiefly related to his World War II Army service as a private first class with the 458th Engineer Depot Company. Included are a photograph of Banton in uniform, an application for national service life insurance, his separation qualification record, and honorable discharge papers. Also included are Banton's obituary and a photograph of his military grave marker. Gift of Lois E. Blatto, Powhatan. (50242)

Binford, William F., Jr. 1 reel of microfilm. (*Misc. reel 6076*)

Autograph collection, 1812–1879, of William F. Binford, Jr. (1940–1997) of Prince George, Virginia. The collection contains signatures of prominent Confederate and Union military figures from letters, military records, legal documents, receipts, as well as clipped signatures. Also included is published biographical information for some of the individuals. Lent for microfilming by Mary Binford, Chester. (45593)

Bouldin, William D. .225 cubic feet.

Papers, 1863–1919, of William D. Bouldin (1839–1917) of Charlotte County, Virginia, and Christian and Todd Counties, Kentucky. Includes letters written by and to him while he was being held prisoner at Point Lookout, Maryland, during the Civil War. The majority of the collection is correspondence between him, after he settled in Kentucky, and his sisters, who either remained in Virginia or also moved to Kentucky. Also contained in the collection is information on the 18th Virginia Infantry, including battles fought, numbers of troops involved, killed in action, and wounded, and a list of officers. There are also typed excerpts from the diary of Sally Ann (Bouldin) Osborne, transcribed by her daughter Alma Osborne Pickett. Gift of Frances McGowan, Hopkinsville, Kentucky. (50231)

Inventory of property, 1 April 1845, of George Byars of Washington County, Virginia, giving a description and value of real property and three slaves. Purchased. (45426)

Coleman, Sylvester.

Papers, 1942–1945 and undated, of Sylvester "Pete" Coleman (ca. 1906–1964) of Lynchburg, Virginia, while serving with the 534th Amphibian Tractor Battalion during World War II. Included are clippings of war-related comics and news articles; various postcards, most written to Coleman's wife, Verna "Lucy" Coleman (1913–1997), by him and by other family and friends; several pieces of memorabilia, including a short snorter and a copy of a card certifying Coleman's induction into the Sacred Order of the Golden Dragon (given upon crossing the International Date Line), a "Fighter's Guide" featuring patriotic and religious readings, and a September 1945 newsletter of the 28th Replacement Depot; various snapshots of Coleman, his fellow servicemen, and scenes from their time in Hawaii and Saipan, as well as a yearbook-style page with studio

portraits of the members of the 534th; and miscellaneous documents from Coleman's service, 1943–1945, including a presidential unit citation for the 534th's role in the seizure of Saipan and Tinian in the Mariana Islands Campaign. One oversize photograph, taken by the *Fort Lewis Sentinel* of Fort Lewis, Washington, shows servicemen lining the deck of an unidentified ship; possibly the one on which Coleman returned to the United States in 1945. Danne, Charles. 1 leaf and 2 pages.

Papers, 1893, of Charles Danne (1844–1932) of Louisa County, Virginia, consisting of a statement, 4 November 1893, from Stokes and Dunn, tailors of Richmond, Virginia, for payment for a suit for one of his sons, either Charles Danne (1872–1933) or William Scott Danne (1874–1908), and a receipt, 9 November 1893, for subscription payment for the *Religious Herald*. Purchased. (44470c)

Duke, Raleigh A. 4 leaves.

Letter, [1945], from Raleigh A. Duke, Jr. (1926–), to his mother in Gordonsville, Virginia, written while serving as a Torpedoman, 3rd Class, aboard the destroyer U.S.S. *Ringgold* (DD-500). Duke wrote his short note at the end of a newsletter printed by the ship, detailing their activities from January to August 1945. The *Ringgold* spent the first several weeks of that period in San Francisco undergoing an overhaul while its crew was on leave. The next several months saw it become part of Task Forces 58 and 38, with operations in the waters near Tokyo, Iwo Jima, Okinawa, Honshu, and Shimizu, with stops in the Caroline Islands, Marshall Islands, and Philippines. Fleenor Family. 1 leaf.

Bond, 16 February 1855, of Isaac Fleenor (1799–1879), Sampson Fleenor (1800–1876), and Solomon Fleenor (d. 1858) agreeing to abide by a division of property in Washington County, Virginia, owned by the estate of Mathias Andis (ca. 1760–ca. 1810), who was the father-in-law of the three men. Gift of James L. Veach of Goffstown, New Hampshire. (45432)

Friou Family. 1 reel of microfilm. (*Misc. reel 6077*)

Papers, 1832–1896, of the Friou family of Brunswick County, Virginia, and North Carolina, notably John D. Friou (1799–1873), and his daughters Annie F. Bogart (b. 1827), Caroline Greer (1822–1897), Sarah P. Friou (1837–1923), and son Andrew Jackson Friou (1834–1904). Includes correspondence, photographs, poetry, copies of compiled service records, and other items. Subjects include family news, health, and events in Goldsboro and Wilmington, North Carolina. The letters from Andrew J. Friou were written while he was living in Staunton during the Civil War, and then serving with the 59th Virginia Infantry in Petersburg near the end of the war. There are transcriptions of many of the letters. Lent for microfilming by Mary Binford, Chester. (45592)

Gardner, David. 7 pages.

Affidavits, 17 January 1849, of Dexter Ball (b. ca. 1773), Solomon Sibley (b. ca. 1788), and Daniel Warner, all of Worcester County, Massachusetts, stating that they had known David Gardner (d. 1830) and that he had spoken of his service in the United States Navy aboard the *Bonhomme Richard* under command of Commodore John Paul Jones (1747–1792) and aboard the *Alliance* under command of Captain Pierre Landais (1731–1820). The affidavits were given to Sullivan Fay, justice of the peace. Donor information unavailable. (45301)

Green, Ardath Jo. 1.35 cubic feet.

Genealogical research files, 1965–2006 (bulk 1981–2006), compiled by Ardath Jo Green (1923–) of Lee, Prince George, and Henrico Counties, Virginia, include extensive files on the Green family, as well as information on related Blankinship, Drake, Ellison, English, Grigg, Harber, Hopper, Kilgore, Ludlow, Marshall, Morgan, Payne, Snavelly, Tobler, Vannoy, and Witt lines. Green compiled this research in part to secure membership to various lineage-based organizations, including the Daughters of the American Revolution, National Society Colonial Dames XVII Century, National Society of the Dames of the Court of Honor, and The Guild of St. Margaret of Scotland. Some of her application paperwork is also contained in the collection. Gift of Ardath Jo Green, via Barbara Owens, Richmond. (50241)

Green, Ardath Jo. .06 cubic feet.

Papers, 1944–2005 and undated, of Ardath Jo Green (1923–) of Pennington Gap, Lee County, Virginia (later a resident of Prince George and Henrico Counties), a veteran of nearly 24 years of service with the United States Navy, beginning in 1943. Items collected here include several photographs of Green and comrades in uniform. Many were taken at the Recruit Training Center in Bainbridge, Maryland, where she completed three tours, and from which she retired as a Chief Disbursing Clerk in 1967. Also included are newspaper clippings, programs from WAVES reunions in 1947 and 1948, a 1949 letter from a Navy chaplain in Norfolk to Green's mother commending her daughter's participation with the chapel choir, and photographs of Green reuniting with fellow servicewomen, 2005 and undated. Grindstaff, Henry T. 1 volume (35 leaves), photocopies.

Gunner's log, 1944–1945, of Henry T. Grindstaff (b. 1925) of Appalachia, Wise County, Virginia, while he was serving with the 483rd Bombardment Group during World War II. The log records information relating to various B-17 training and combat missions which he flew. The handwritten entries include date, time, and place of embarkation, temperature, altitude flown, intended target, enemy encounters, and return time. Gift of Henry T. Grindstaff, Troutville. Inglet, T. W. G. 1 leaf and 14 pages.

Letters, 1862–1865, of T. W. G. Inglet (Inglett) (1839–1910) of Company C, 28th Georgia Infantry, to his wife, Martha A. Inglet (1843–1916) of Richmond County, Georgia, providing news of himself and the regiment, including service and fighting in

Virginia, South Carolina, and Florida; describing the battle of the Crater at Petersburg, Virginia; remarking on the fall of Atlanta; commenting on the deaths of his children; and detailing his wounding and subsequent stays in hospitals. Also includes a letter from William H. Little of the 28th Georgia Infantry to his sister, A. D. V. Palmer. Purchased. (50160)

Jamison, William Andrew. 1 leaf.

Commission, 8 February 1865, for William Andrew Jamison (1841–1919) as 2nd Lieutenant for Company C, 5th Virginia Cavalry. Donor information unavailable. (50116)

Long, Richard. 1 vol. (ca. 230 p.).

Memoir, entitled “A World War II Love Story,” written by Richard E. Long (1919–). Through the lens of his relationship with Rubye Seago, whom he met in Lawrenceville, Virginia, while registering for the draft in October 1940 and married in 1943, Long recalls his World War II experiences. The memoir consists mainly of copies of letters written by Richard and Rubye, and Long’s recollections of their relationship, along with details of his military service. Letter, 25 May 1862, from Charles P. Shepard of Company E, 1st Regiment, United States Sharpshooters, to his father, Jonathan C. Shepard of Merrimack County, New Hampshire, discussing the Union Army's approach to Richmond, Virginia, and stating that the Confederate capital will fall; noting that the army has a railroad running for it; and commenting on military life.
