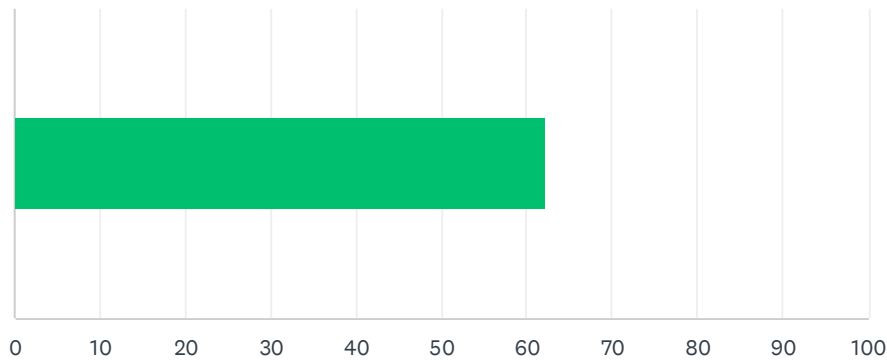

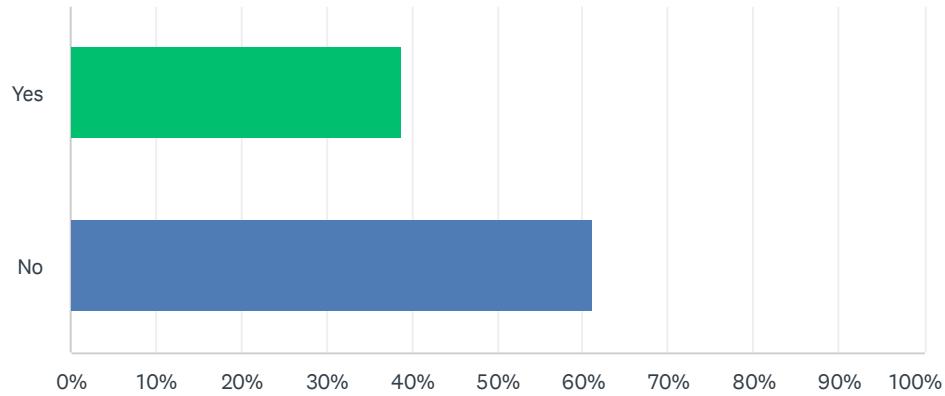

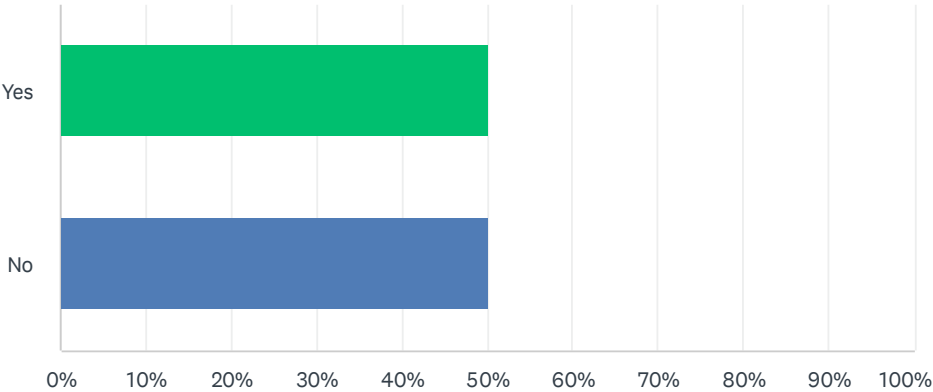

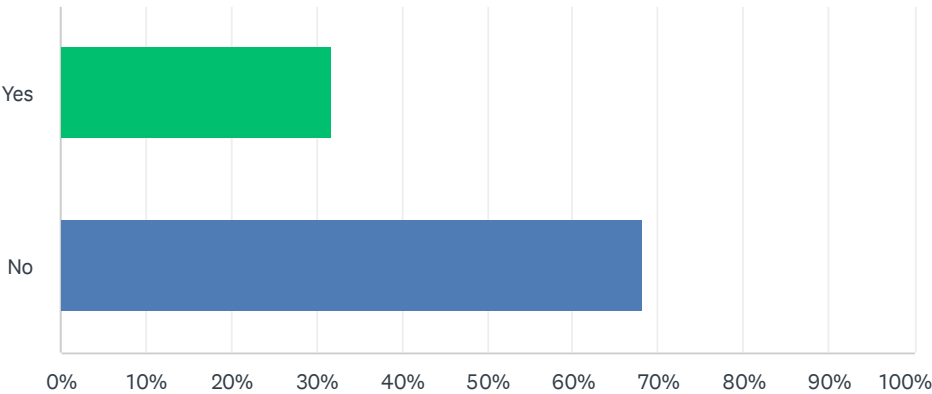

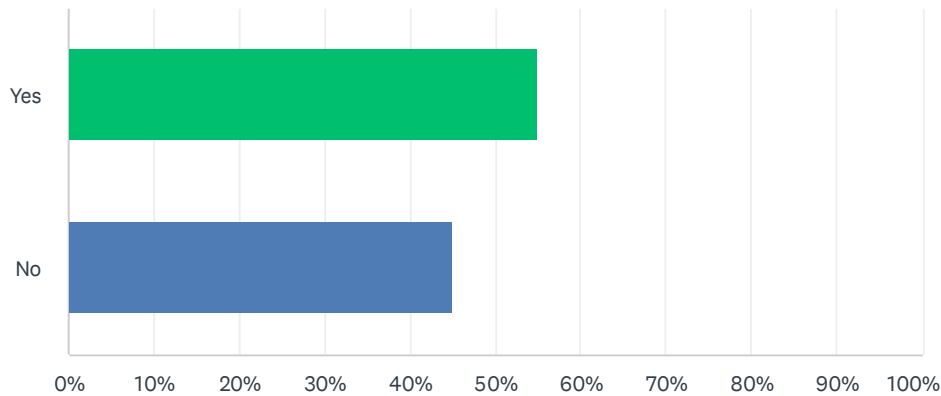

Q9 Are temperature and relative humidity monitored throughout the facility?

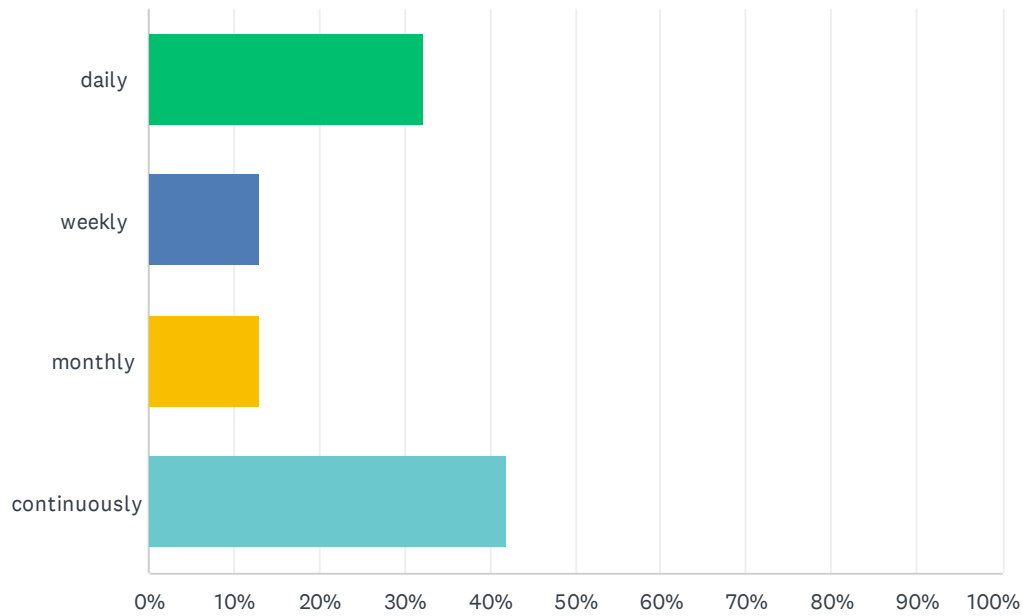

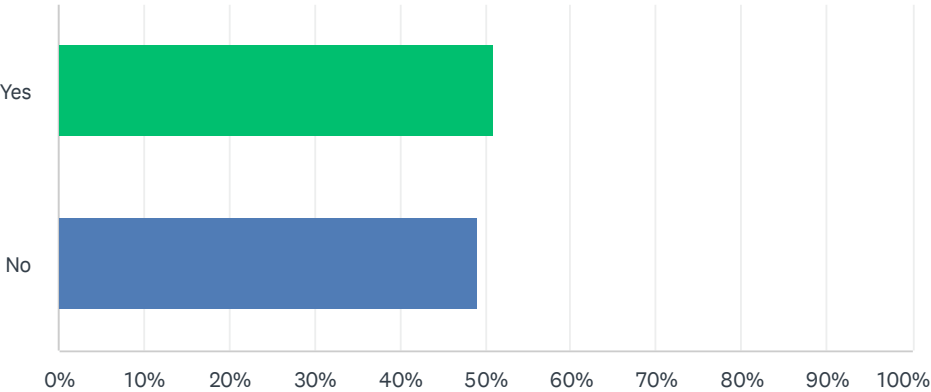

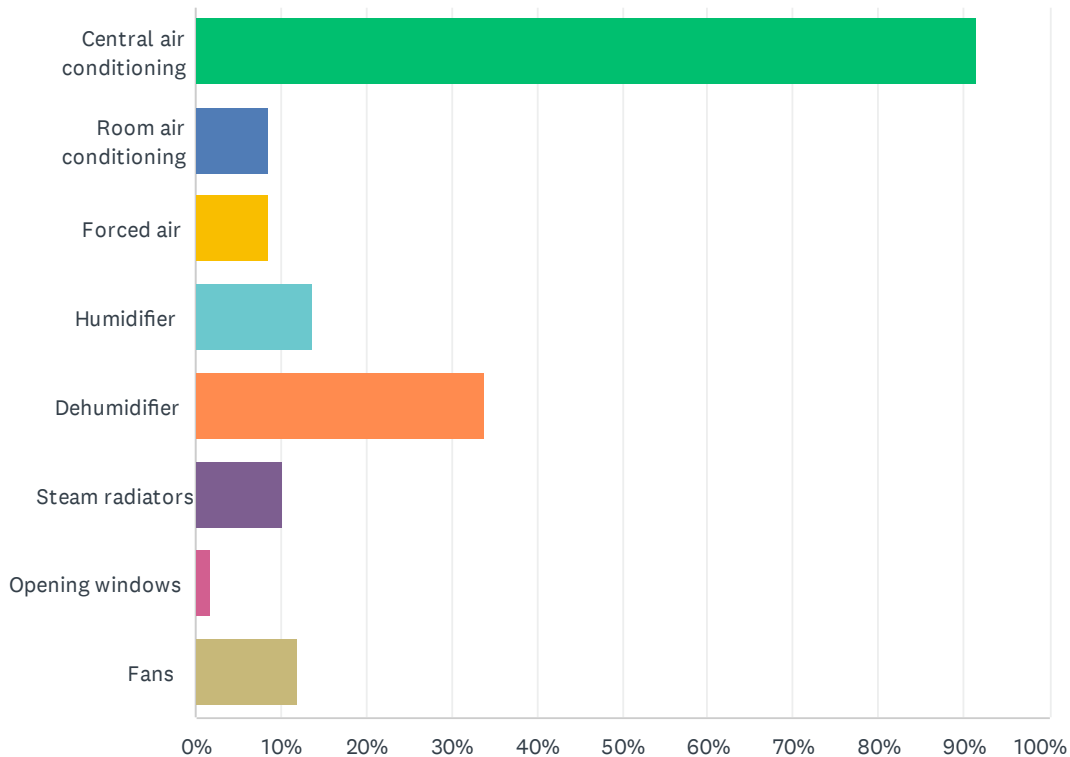

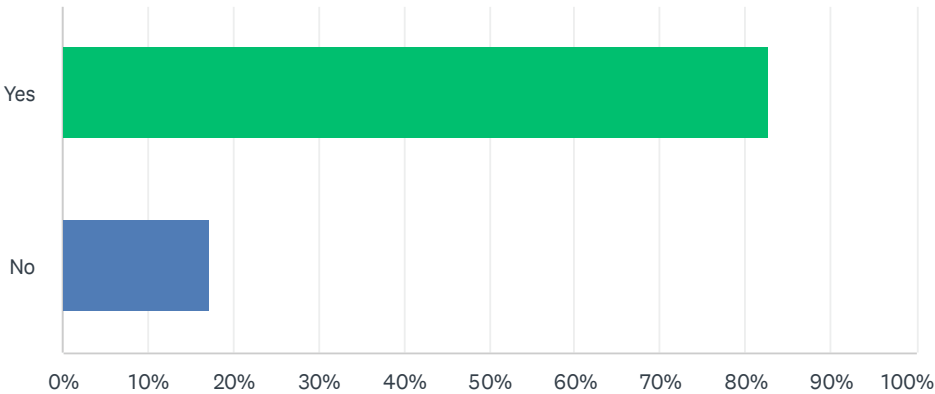

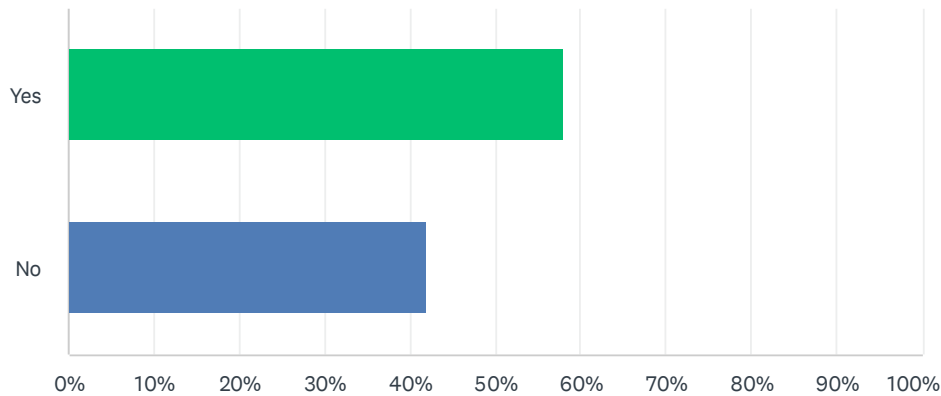

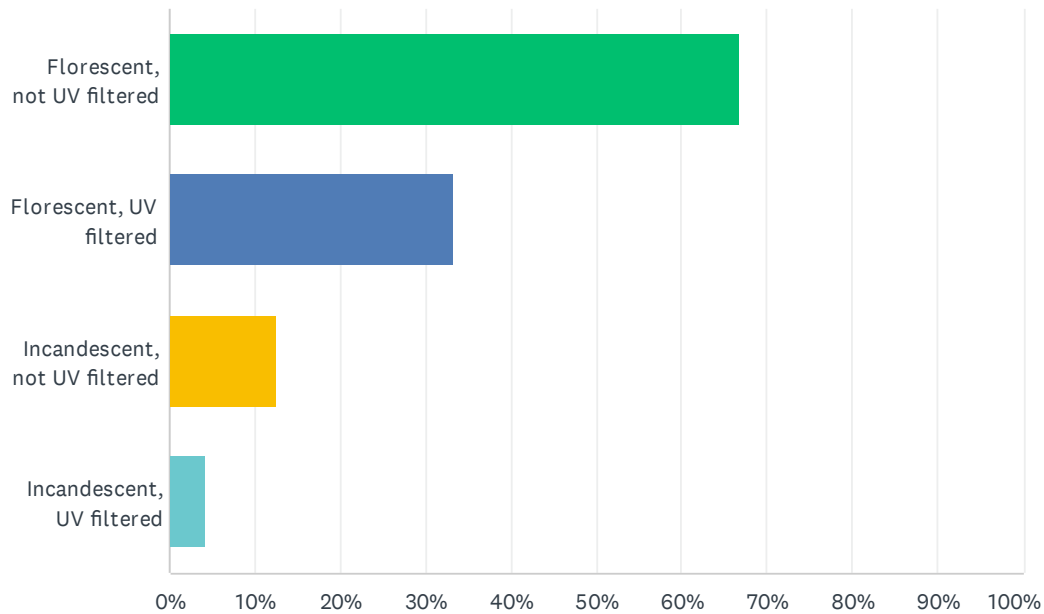

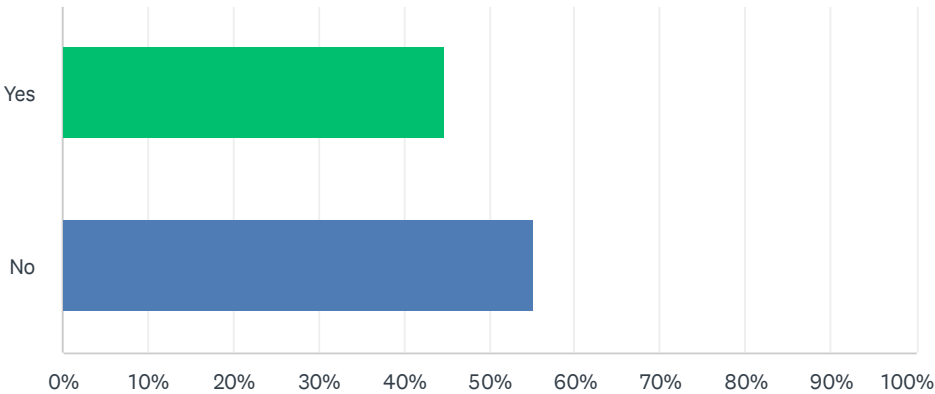

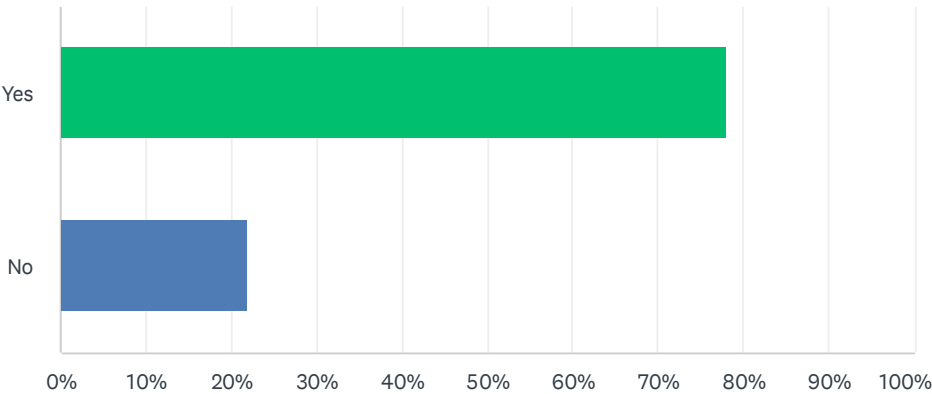

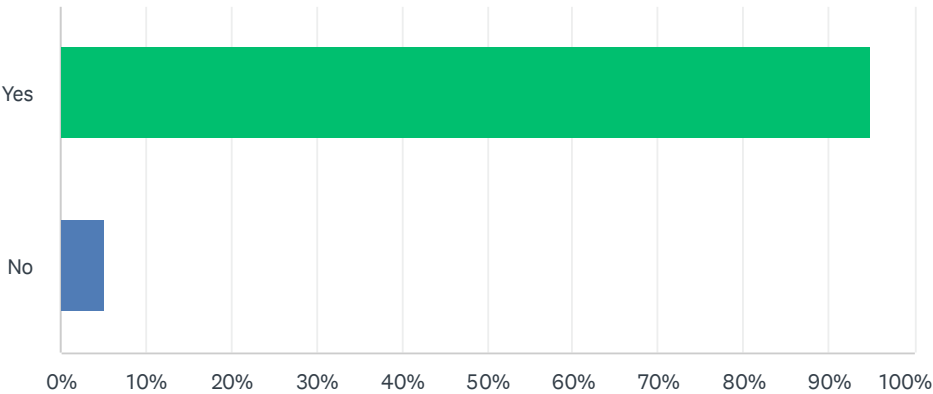

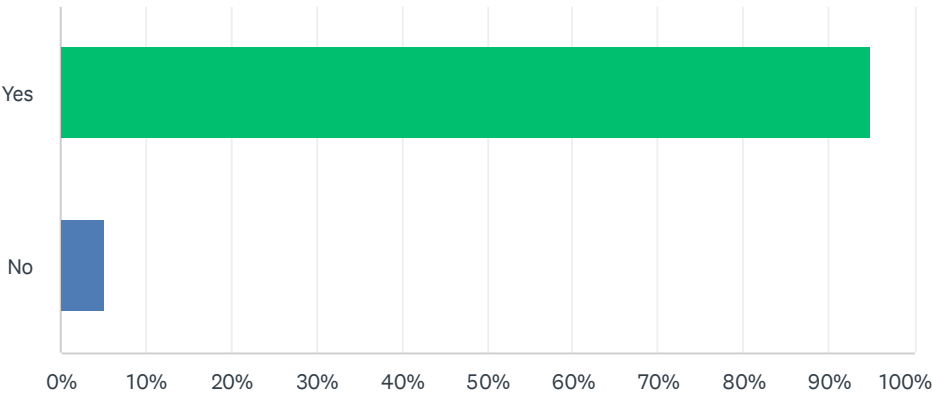

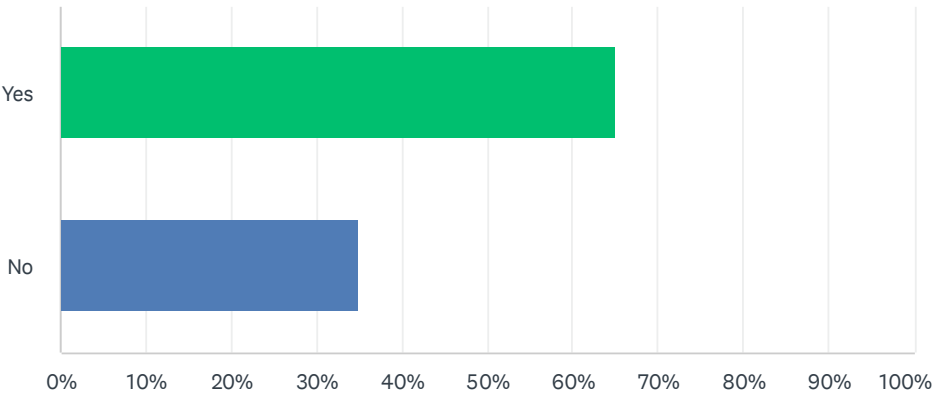

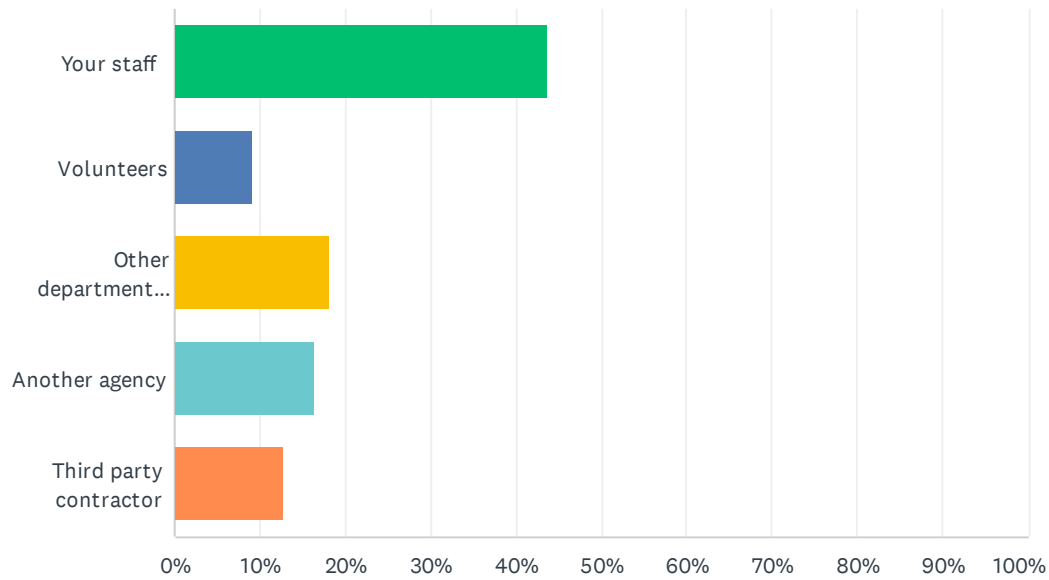

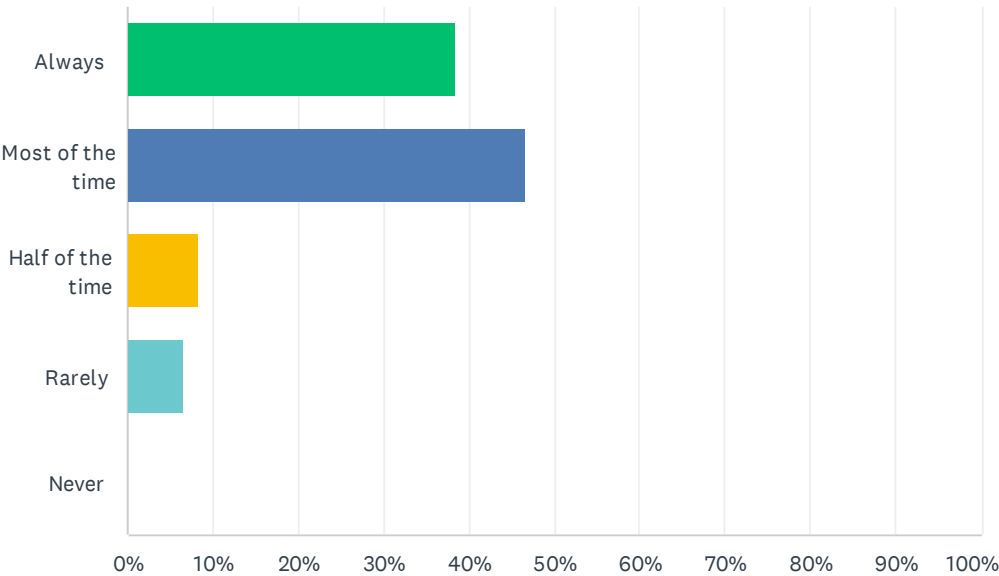

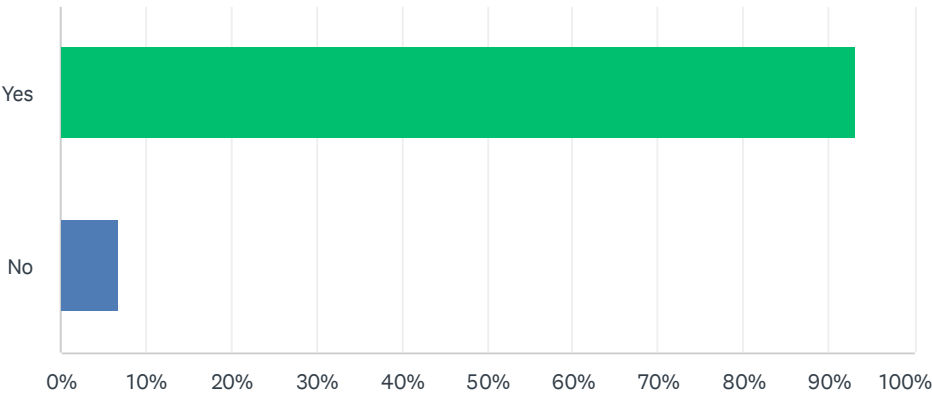

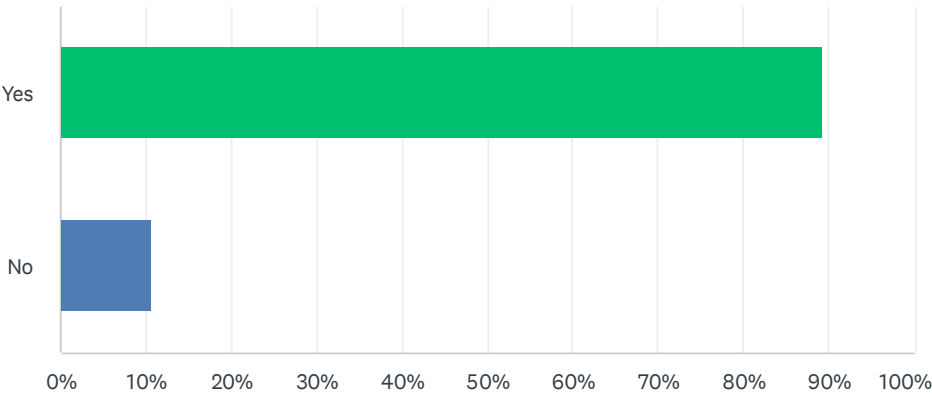

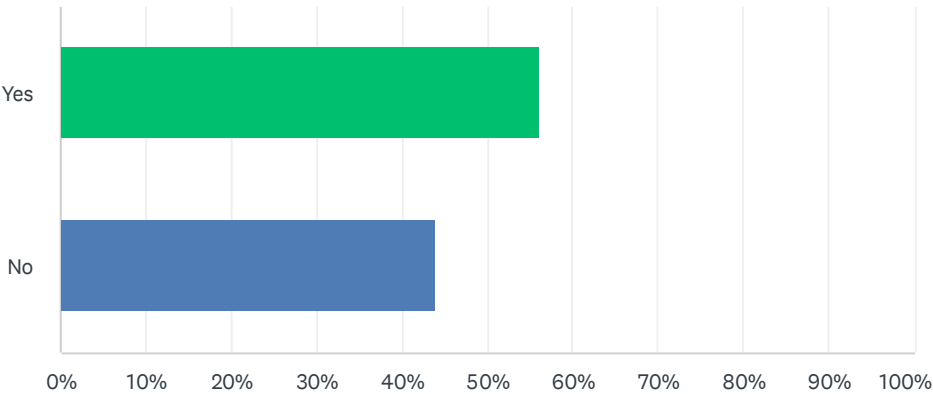

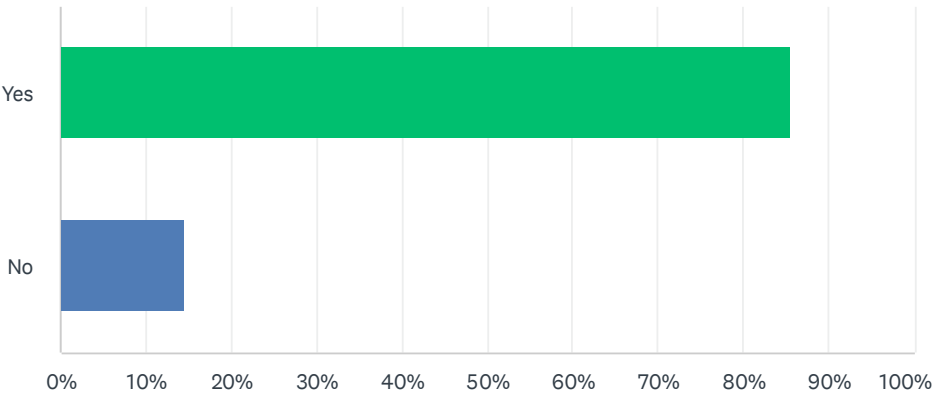

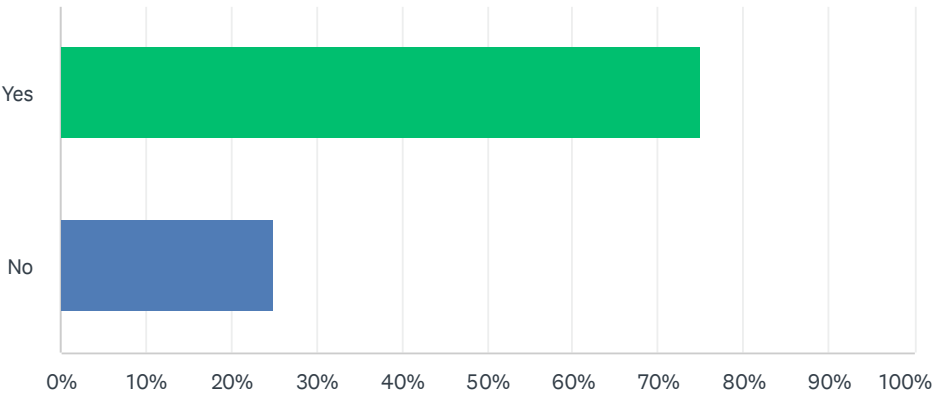

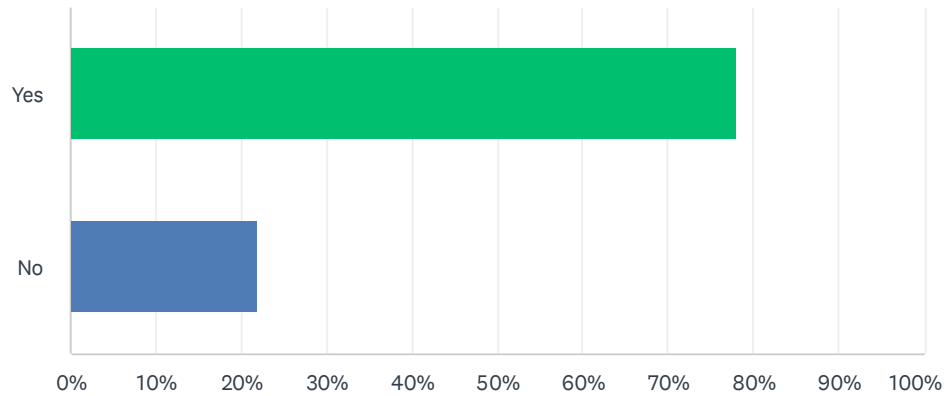

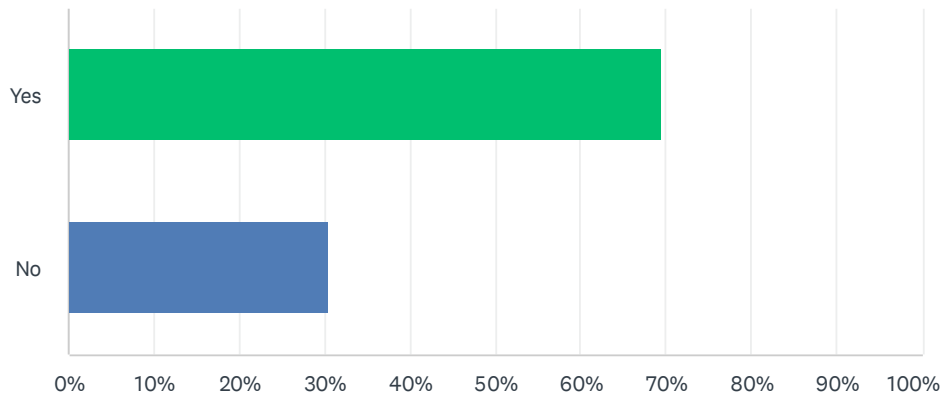

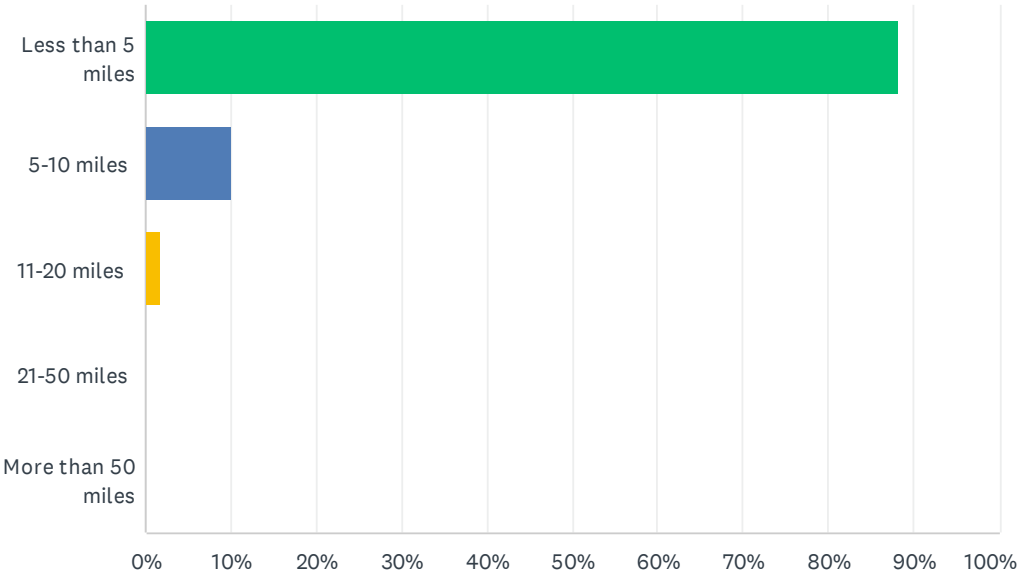

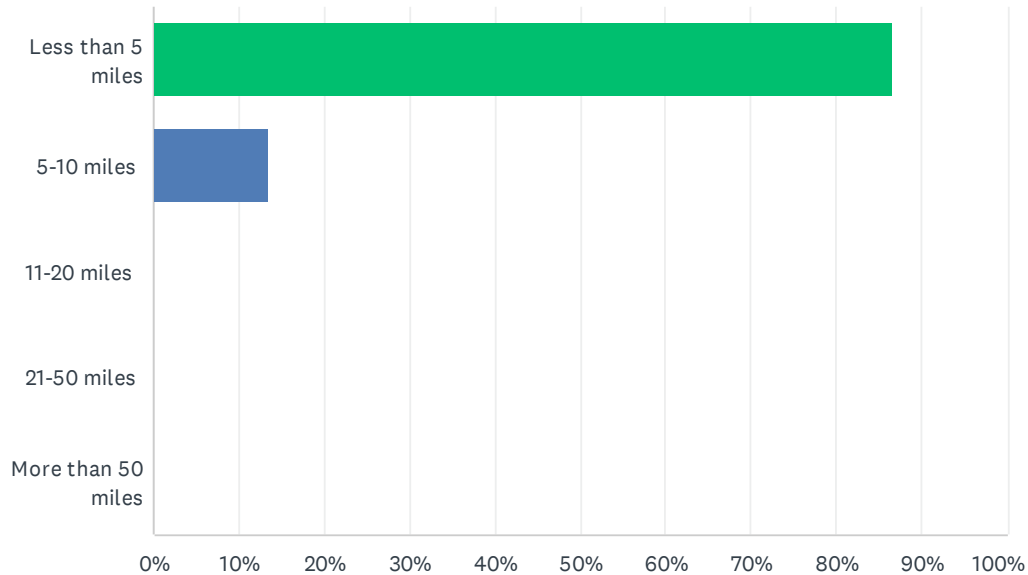

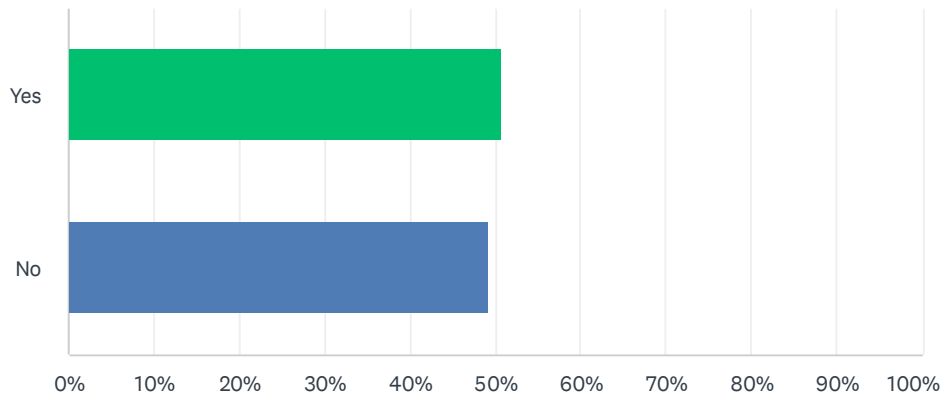

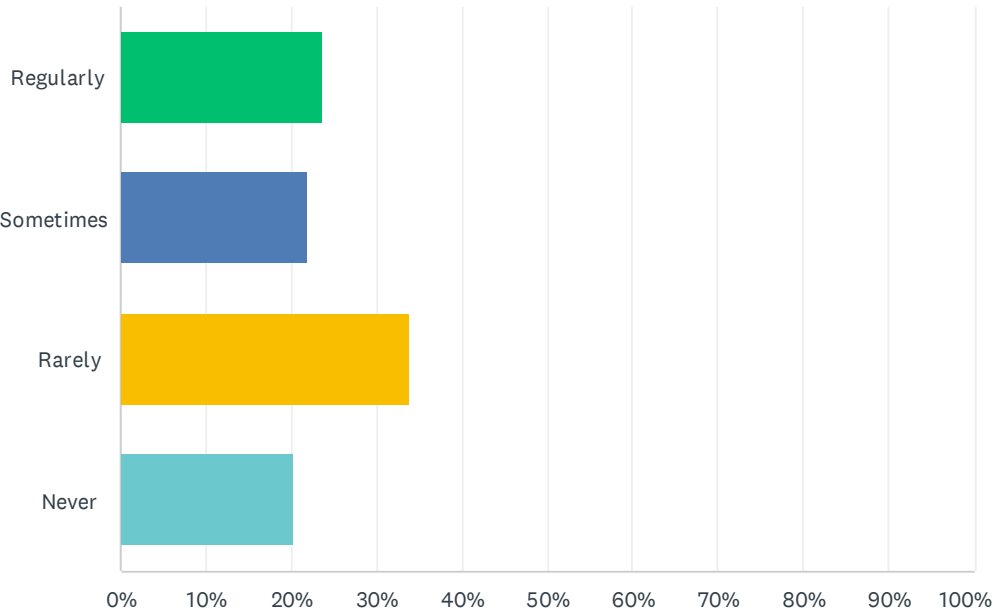

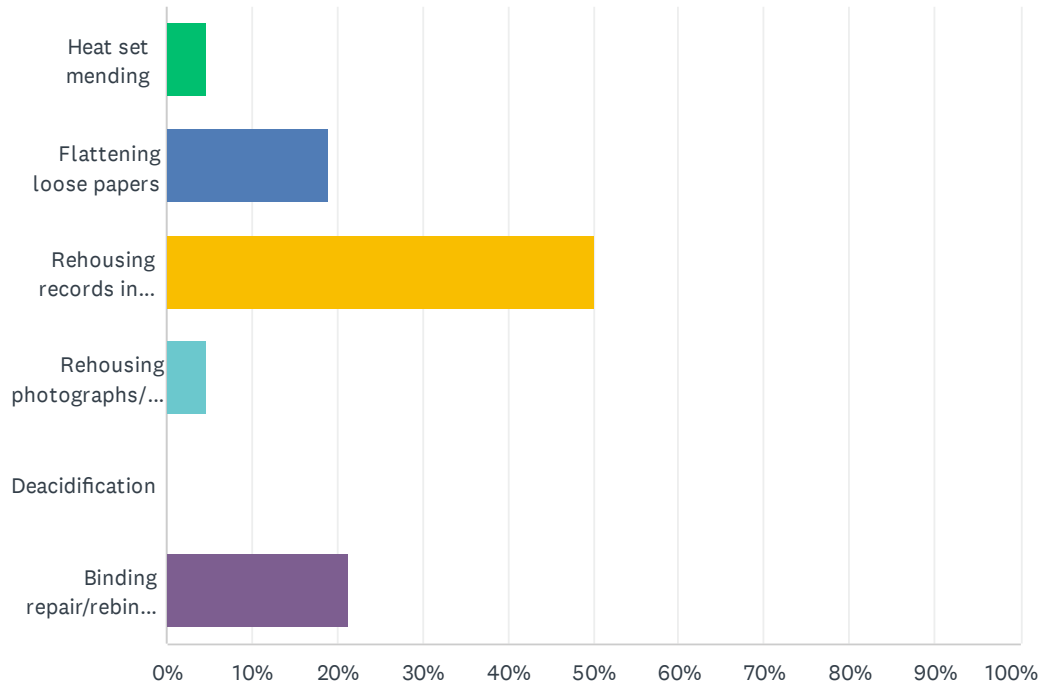

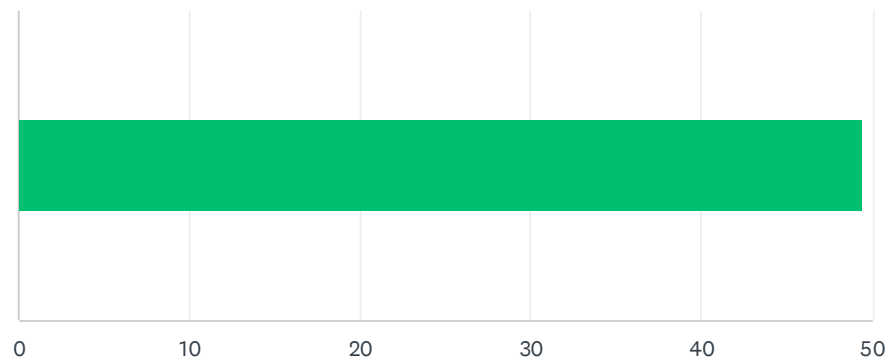

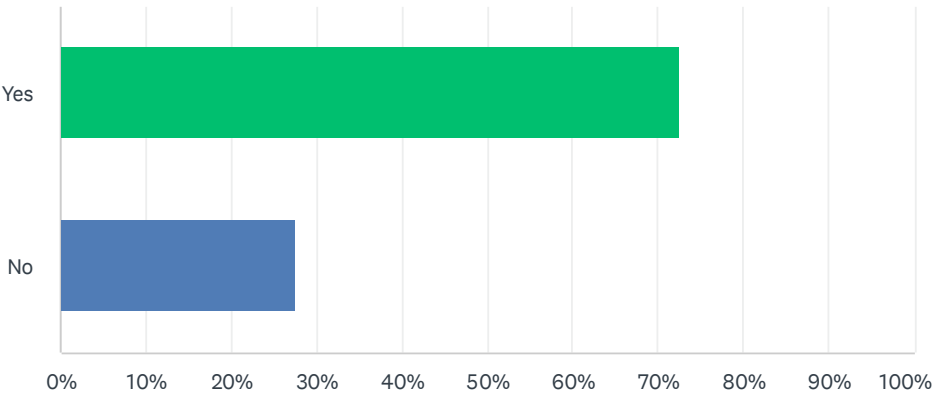

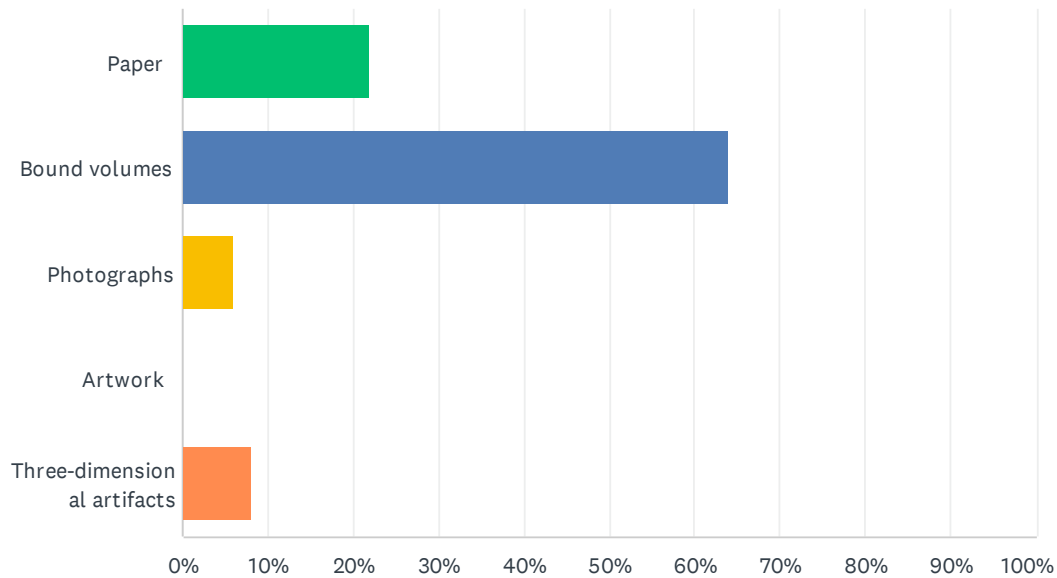

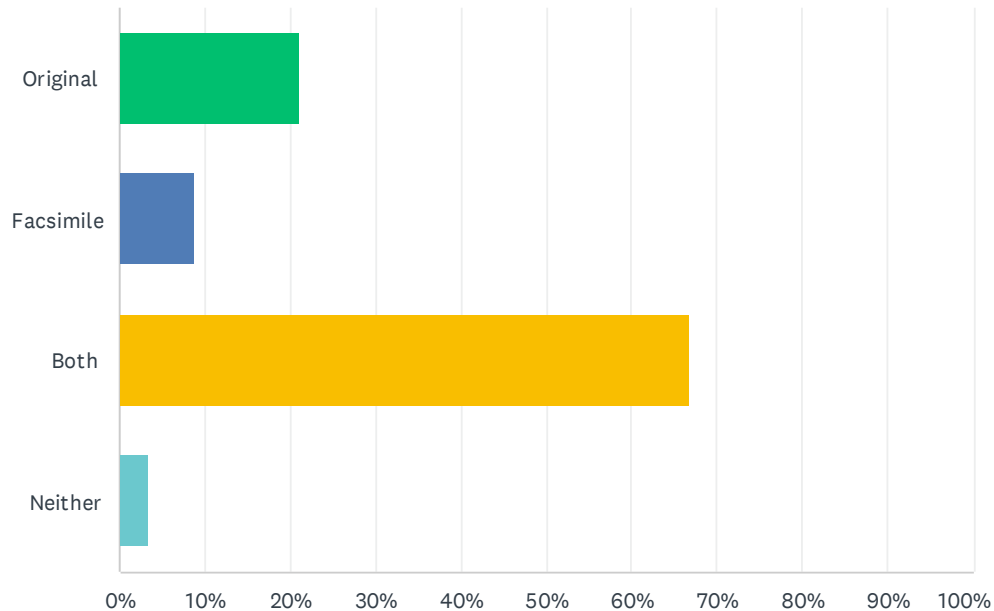

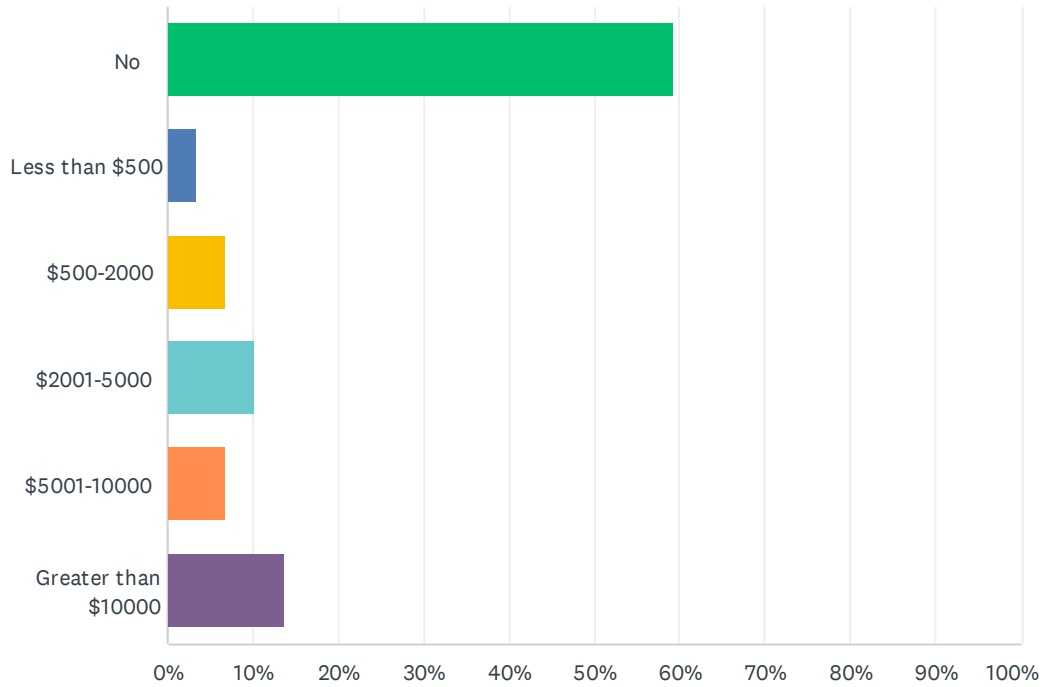

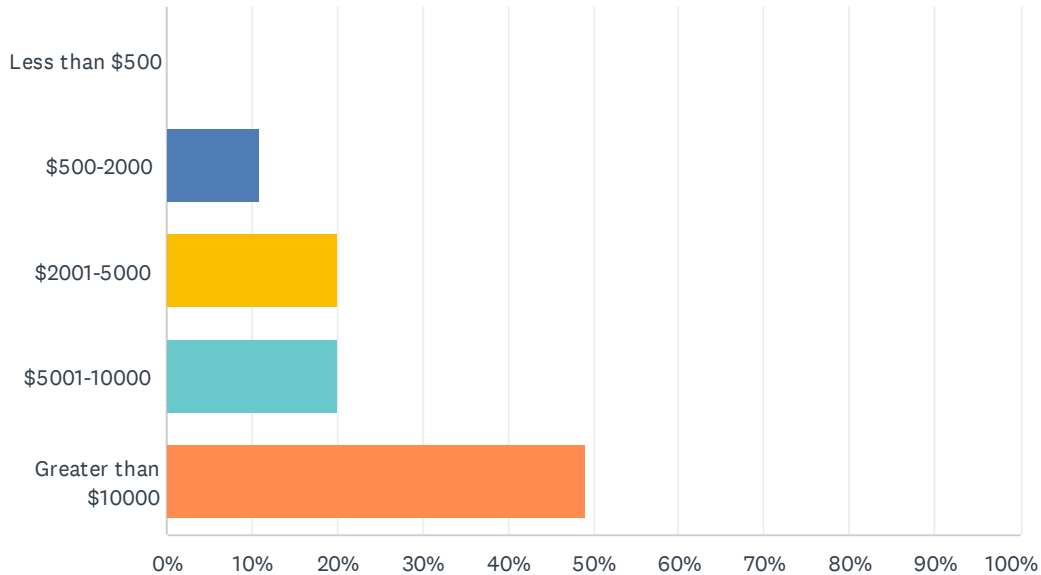

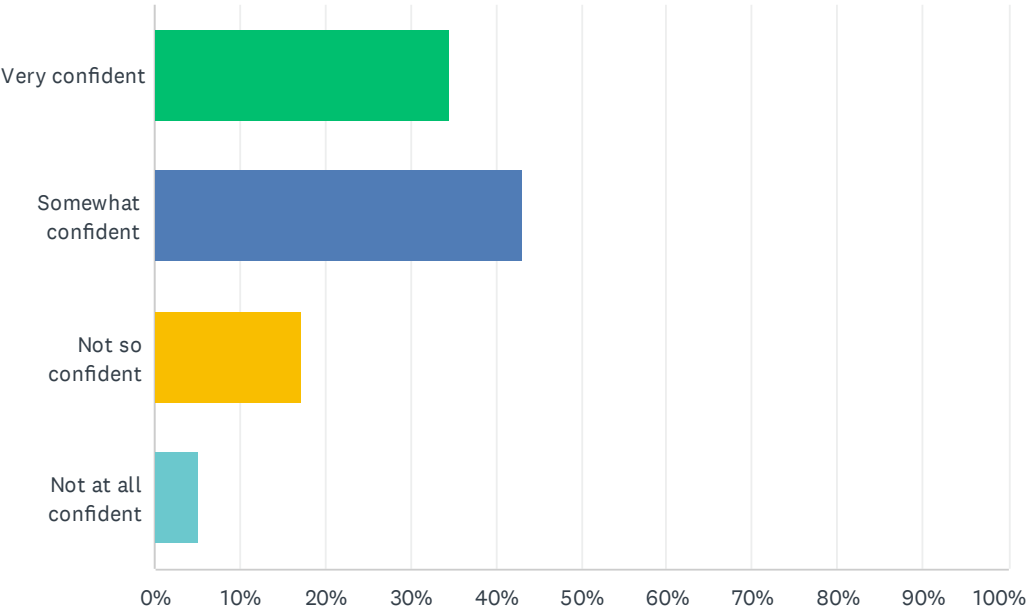

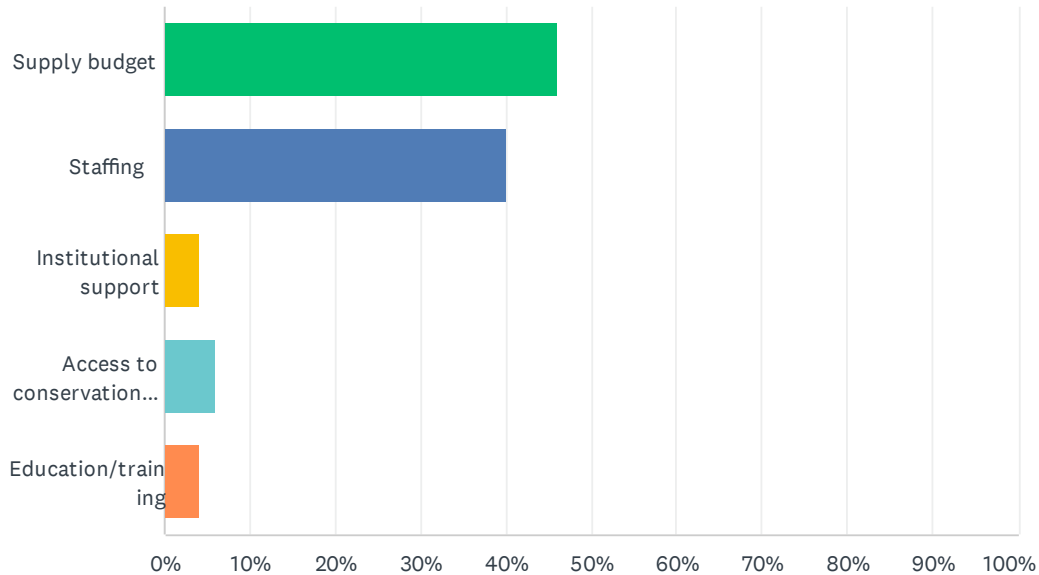

Q52 What are your current barriers to pursuing conservation or preservation work?

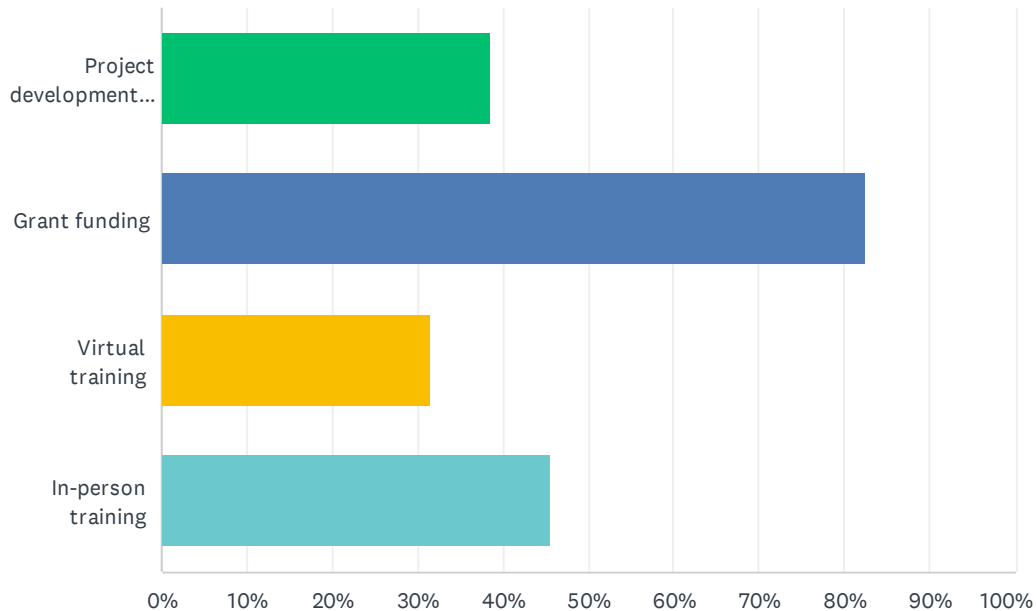

Q53 What general support services would you recommend SHRAB offer in the future to assist you with preservation, accessibility, and/or records management?

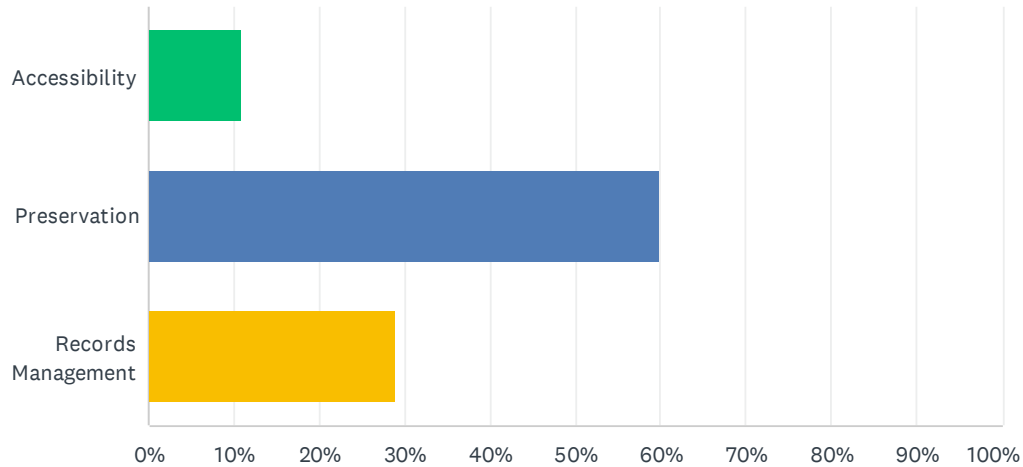
