SUMMARY OF THE MEETING
2014-A Cycle — November 21, 2013

The members of the board present were the Honorable Circuit Court Clerks Diane Mumford, Lancaster County; Maetta Crewe, Pulaski County; and Terry Whittle, City of Winchester. Board members present from the Library of Virginia were Sandy Treadway, State Archivist and State Librarian of Virginia, and Gregory Crawford, Local Records Program Manager. Support staff members present were Michelle Washington, Administrative Assistant, and Carl Childs, Director of Local Records Services and Grants Coordinator, who moderated the meeting. The meeting was called to order at 9:15 AM.

There were thirty-three applications submitted from thirty localities totaling \$425,061.00. The grant review board evaluated and discussed all of the applications, and awarded thirty-two grant projects for \$408,021.00. The board agreed unanimously that the Item Conservation category was its highest priority for funding projects in this cycle. The request from Rockingham County was adjusted downward \$8,718.00. Requests from Isle of Wight and Madison Counties were cumulatively adjusted upward by \$1,088.00. A funding request from Wise County in the Reformatting category was denied.

A full list of the awarded projects follows below.

There being no further business by this board, the meeting adjourned at approximately 11:15 am.
