The Board proceeded to evaluate ninety-four grant applications. The sum of all projects totaled \$1,441,194.21. After a thorough discussion, the board unanimously agreed that Item Conservation projects should be given the highest priority in this cycle. A total of three applications was denied. The Board approved ninety-one grant projects with all awards totaling \$1,221,463.16.
