<u>Aqenda</u>

Old Business

182-056, Virginia Employment Commission, Unemployment Insurance Division

Corey Smith presented this schedule. He explained that the agency reviewed their schedules and discovered redundancy in old schedules dating back to the 70s and 80s when each series was a separate schedule. The agency decided to update series and defunct redundant series and schedules. Schedule 182-056 will supersede schedules, 182-44, 182-55, 182-56, 182-57, 182-158, and 182-158R. Additionally the series title and series number under 182-158 will be moved over to 182-056. Records series 015069, Claimant Files from schedule 182-158 was updated and will be moved to schedule 182-056 to supersede "claim files, series 018256."

182-163, Virginia Employment Commission, Administrative Law

Corey Smith presented this schedule. Smith explained this is a new schedule for the division with Lower Authority and Higher Authority Appeal Cases Files.

440-008, Environmental Enhancement Division

The agency is adding a series for Coastal Zone Management Program Grants Files to be retained for 50 years. The retention period is based on agency reference and research needs for past files.

The series presented today on these schedules will be superseded by records series on General Schedule 101 and schedules 501-003 and 501-021 will be made defunct.
