Letter, 24 March 1857, from John Minor Botts, Richmond, Virginia, to William H. E. Merritt (ca. 1800-1885), Brunswick County, Virginia. Botts writes on behalf of Mr. McDaniel concerning an agreement of purchase of colts by McDaniel from Merrett. Purchased. (52064)

Brown, Edward Smith. 3 pages.

Letter, 27 February 1842, from Edward Smith Brown (1818-1908) at Randolph-Macon College in Mecklenburg County, Virginia, to his sister Mary C. Brown (b. 1810) in Cumberland County, Virginia, regarding whether he will be able to attend her upcoming wedding because of school work. He also mentions his friend Marion who is ill and says attention from the young women of Cumberland County might improve his health. Brown asks to be remembered to friends and family. Purchased. Kidd, Ellen Gertrude Tompkins. 1.28 cubic feet.

Papers, 1791-1998, of Ellen Gertrude Tompkins Kidd (ca. 1846-1932) of Richmond, Virginia, consisting of business records, compositions, correspondence, deeds, insurance policies and records, legal records, money, photographs, poems, receipts, and wills. Papers detail Kidd's Pin-Money Pickle business, her and her family's travels through the United States and Europe, women's suffrage, and Richmond society and culture, as well as the Boulware, Kidd, and Tompkins families. Letter, 6 January 1862 [1863], from Emmett Martin with the Army of Northern Virginia at Fredericksburg, Virginia, to his wife, telling her how much he misses her and commenting on his hopes and dreams. Martin also mentions friends in the army and comments on the battle of Stones River (Murfreesboro, Tenn.), fought earlier on 31 December 1862-1 January 1863. Purchased. (52059)

Letter, 19 February [1851?], to James B. Peake (b. ca. 1802) of Spotsylvania County, Virginia, from his sister M. A. M. in Charlottesville, Virginia, sending personal and family news, and asking for Peake's assistance in paying off some personal debts. She mentions Peake's daughter Molly (b. ca. 1836). Purchased. Proffit, George. 3 pages.

Letter, 21 August 1843, from George H. Proffit (1807-1847), minister to Brazil, to George Law (1785-1848) of Baltimore, Maryland, asking Law for his views and for information regarding trade and claims with Brazil. Includes letter, same date, from William Maxwell Wood (1809-1880) in Portsmouth, Virginia, asking Law to assist Proffit. Purchased. (52060)

Robinson, J. 2 pages.

Letter, 13 February 1845, from J. Robinson (1773-1850) of Richmond, Virginia, to Arthur Emmerson (1817-1870) of Portsmouth, Virginia, regarding cases that involve Emmerson making their way through Henrico County Circuit Court and the court of appeals. Purchased. (52063)

Schoolfield, William. 4 pages.

Letter, 13 September 1849, from William Schoolfield (b. ca. 1828), Portsmouth, Virginia, to his sister Louisa Ashton Schoolfield McGill (b. ca. 1812), Middlesex County, Virginia, discussing family and Portmouth social news. Schoolfield also mentions his legal education and possible plans for his future. Purchased. (52062)

Scruggs, William B. 2 pages.

Letter, 19 April 1866, from William B. Scruggs, Bedford County, Virginia, to Edward S. Brown (1818-1908), Cumberland County, Virginia, concerning Scruggs' debt to his Aunt Rhoda. Scruggs notes that he has had to sell some of his property to provide for his family and may have to sell most of the rest to pay his debt. Purchased. (51994)

Wilson, Margaret P. 46 leaves.

Biography, 2017, of Richard Samuel Fennell Peete (1829-1900) of Charlotte County, Virginia, and Warren County, North Carolina, detailing his college and medical education at the University of Virginia, and the University of Pennsylvania and his career as a medical doctor. The biography includes information on Peete's service as a military surgeon with the 12th North Carolina Infantry. The work also contains information on his two wives, Mary Armstead Davis Peete (1837-1873) and Catherine Jane Nicholson Peete (1838-1912) and their children. Gift of Margaret P.
