David Judah and Company. 40 pages.

Records, 1821-1826, of David Judah & Company consisting of business correspondence between David Judah, Tobias J. Tobias, and Edward Pollock partners in David Judah & Co. The letters also contain references to Judah's parents and sister who lived in New York, as well as news from Richmond and an outbreak of smallpox in 1822. Purchased. (52611)

Franklin Davis and Company (Richmond, Va.). 2 leaves.

Circular letters, 1884, from the Richmond, Virginia, office of Franklin Davis and Company, a nursery. Circular, 3 January 1884, is a job advertisement for sales agents; and circular, 1884, is an advertisement for their fruit stock to farmers. Purchased. (52640)

Letters, 1858-1859, to D. L. Hopkins (1827-1865) of Lexington, Virginia, from Bacon and Baskervill and R. H. Maury and Company of Richmond, Virginia, and from Bruce McClelland (1827-1862) of Nelson County, Virginia, regarding business transactions. Purchased. (52637)

Myers, Moses. 2 pages.

Moses Myers (1753-1835) letter, 22 August 1793 to Moses Brown of Newbury Port, Massachusetts thanking him for an introduction to Mr.'s Pittingail and Smith, as well as referencing an abundant wheat crop. Also contains price list for items shipped to Lisbon and Hadiz. Purchased. (52855)

Account, 30 June 1858, from the Richmond Female Institute for sheet music furnished to Lizzie Cheuning by Nathan B. Clapp, head of the music department. Purchased. (52638)

PERSONAL PAPERS

Black, Samuel. 4 pages.

Inventory, 16 February 1816, of the estate of Samuel Black (d. 1815) of Albemarle County, Virginia, made by William Ramsay, Oliver Cleveland, and James Hays, by order of the Albemarle County Court. Inventory lists value of property including slaves, crops, farm implements, and other items. Purchased. (52623)

Cary, Cyrus. 7 pages.

Circular letter, 1828, written by Cyrus Cary (1794-1832) for the Greenbrier County, (West) Virginia, supporters of President John Quincy Adams (1767-1848) advocating his reelection to the office and opposing the candidacy of Andrew Jackson (1767-1845). Letter is a handwritten draft. Purchased. (52673)

Cooper, Henry Jackson. 3 pages.

Letter, 27 March 1864, from Henry Jackson Cooper (1833-1908), of Company A, 39th Virginia Cavalry Battalion serving as headquarters guard for the Army of Northern Virginia, to an unidentified woman, recalling their meeting in 1860 and his thoughts on the Civil War. Purchased. (52657)

Fenn, Austin. 14 leaves and 8 pages.

Letter, 24 November 1864, from Austin Fenn (1837-1897) of Company H, 10th Vermont Infantry, to his wife Julia Fenn (1841-1915) in Windsor County, Vermont, detailing the battle of Cedar Creek on 19 October 1864, commenting on the fighting and casualties. He mentions one soldier who seemingly shirked his duty. Also includes transcription of letter and photograph of Fenn. There is also a copy and transcription of a letter, 20 July 1864, from Fenn to his wife during the siege of Petersburg, Virginia. Purchased. (52651)

Garnett, James M. 2 leaves.

Letter, 9 June 1826, from James M. Garnett (1770-1843) of Essex County, Virginia, to Thomas W. White (1788-1843) of Richmond, Virginia. Garnett sends White his note for \$426.50, but asking that he not call for the account. Garnett also wishes White success in his printing business. Purchased. (52684)

Gibbons, Ann. 2 pages.

Order for transportation, 30 March 1866, for Ann Gibbons travelling from Washington D.C. to Richmond, Virginia from the United States army. Gibbons had accompanied African American orphans to Philadelphia, Pennsylvania. Purchased. (52639)

Hall, Atwater. 4 pages.

Letter, 3 June 1862, from Joseph Atwater Hall (1838-1900), of the 5th Connecticut Infantry to his brother Julius Carlton Hall (1841-1913) serving with Company K, 1st California Volunteers. He describes the movements of General Nathaniel Banks' Division of the Union Army during the Shenandoah Valley Campaign of 1862 and the first battle of Winchester. Hall also comments on the Peninsula Campaign and the capture of Fort Pulaski, as well as provides family news. He warns his brother to watch out for "indians" and "sesech." Purchased. (52654)

Howland, Gertrude Clarke Murrell duPont. 2.7 cubic feet.

Papers, 1894-2010, of Gertrude Murrell duPont Howland (1910-2016) consisting of correspondence, editorials, family information, genealogical charts, journals, memoirs, photographs, plays, short stories, and speeches. The memoirs include description of growing up in Richmond, Virginia, her marriage to and subsequent divorce from Alfred Rhet duPont, and her travels to archaeological excavations throughout the Mediterranean and the Middle East. Lancaster Charles H. 4 pages.

Letter, 31 July 1864, from Charles H. Lancaster (1844-1909) of Company C, 11th New Hampshire Infantry, to his parents, describing the battle of the Crater at Peterburg, Virginia, and commenting on the damage, casualties, and use of African American troops. Purchased. (52656)

Leslie, William. 4 pages.

Letter, 17 January 1862, from William Leslie of the 9th Pennsylvania Reserve Regiment (38th Pennsylvania Infantry Regiment) to his friend Emma detailing the battle of Dranesville in Fairfax County, Virginia, that took place on 20 December. He also apologizes for not having written sooner. Purchased. (52660)

Magruder, Julia. 3 pages.

Letter, 8 September 1901, from Julia Magruder (1854-1907), Albemarle County, Virginia, to a Mr. Clemens, possibly William Montgomery Clemens (1860-1931), in reply to his letter, stating that she does not have any manuscripts for sale and asking if he might have a future interest in children's short stories. Purchased. (52625)

Mann, William Hodges. 1 leaf.

Letter, 1 February 1899, signed by William Hodges Mann (1843-1927) and James Mann, and endorsed by John Howard Young (1859-1930) regarding Edward S. Deane, Herman M. Jackson (1881-1899) and the clerkship of Nottoway County, Virginia. Purchased. (52635)

Seawell, Molly Elliot. 3 pages.

Letter, 12 February 1902, from Molly Elliot Seawell (1853-1916), of Washington D.C., to a Mr. Clemens, possibly William Montgomery Clemens (1860-1931), regarding a short story that she might sell to him, although there are other potential buyers for the story. She also states that she has contracted to sell her new book to Bowen Merrill Company (later Bobbs-Merrill Company). Purchased. (52624)

Skinner, J. S. 2 leaves.

Letter, 20 January 1839, from J. S. Skinner (1788-1851), Baltimore, Maryland, to John [Henry] A. Wise (1806-1876), House of Representatives, Washington, D.C., regarding Wise's unfavorable mention of him in a speech on office holders. Skinner opposes the "spoils system" for filling federal offices. He tells Wise that his region of Virginia might be good for silk. Purchased. (52685)

Wallace, William F. 6 pages.

Letters, 1862, 1864, from William F. Wallace (alias for William F. Smith) of Company B, 1st Massachusetts Infantry, to his mother Ann Smith, residing in Middlesex and Norfolk Counties, Massachusetts. Letter, 14 April 1862, describes the siege of Yorktown, Virginia, during the Peninsula Campaign and describes skirmishing between the Union and Confederate armies. Letter, 19 May 1864, describes fighting during the the battles of the Wilderness and Spotsylvania Courthouse. Wallace also describes how pickets from both armies would meet and talk. Purchased. Wilkinson, Jesse R. 3 pages.

Indenture, 25 March 1843 between James Smith (b. ca. 1822) of the first part, Jesse R. Wilkinson (1800-1875) of the second part, and Francis W. Anderson (b.ca. 1812) of the third part, all of Buckingham County, Virginia, for the sale of 112 acres in Buckingham County from Smith to Wilkinson with payment to satisfy a debt from Smith to Anderson. Deed was recorded 27 March 1843. Purchased. (52636)

Yount Family. 8.95 cubic feet.

Papers, 1808-2011, of the Yount Family consist of correspondence, photographs, account books, diaries, school notebooks, and scrapbooks, general papers, newsletters and newspapers, and ephemera of various members of the Yount and related families. Much of the correspondence, newsletters, and newspapers were sent from Stephens Russell Yount and Glenn Ellyson Yount to relatives in Augusta County, Virginia while they were serving in the military during World War I.
