#### Bank of New Hope (Augusta County, Va.). 1 volume.

Minute book, 1913-1933, of the Bank of New Hope in Augusta County, Virginia, consisting of minutes, financial reports, certificate of incorporation, and subscription lists, as well as correspondence with the Virginia State Corporation Commission (SCC). Also loose papers including certificate of authority, 1 July 1913, from the SCC; certificate, ca. 1918, from the United States Department of Treasury for issuing war bonds; proxies for the stockholders meeting on 12 January 1924; and a notice from banks located in Augusta County stating they will follow the Federal Banking Act of 1933. Deed of lease, 1 October 1858, for use of a building between John Wickham of Richmond, Virginia, as lessor, and Bank of the Commonwealth, Richmond, as lessee. Wickham agrees to provide maintenance and upkeep of the building and the bank agrees to pay rent. Purchased. (52312)

#### Miller and Rhoads (Richmond, Va.). 1 leaf.

Application, 23 March 1945, from Miller and Rhoads to the Richmond, Virginia, Department of Public Works for permission to set up a booth on a sidewalk for sale of war bonds. The booth would be set up no earlier than 13 May 1945. Purchased. (52513)

Ledger from Southampton County, Virginia, consisting of a merchant's ledger, 1842-1846, and a physician's ledger, 1864-1866. Merchant's ledger (leaves 1-360) contains accounts including name of customer, items purchased, and cost. Physician's ledger (leaves 361-423) details cost of visits to and medicine for patients. Log records sailing conditions, weather, location, and other details of the voyage, including the arrival of Commodore Matthew C. Perry (1794-1858) as commander of the squadron. Log is in the hand of William L. Maury (1813-1878) from 21 July 1850 to 12 November 1852. Purchased. (52607)

#### Brower, Frank S. 3 pages.

Letter, 28 November 1918, from Frank S. Brower (1891-1962) serving with a military hospital in France to his father S. M. Brower (1866-1944) of Waynesboro, Virginia. Brower details the route of his outfit to France and describes the differences between the architecture and railroad engines in France and in the United States. Purchased. (53320)

## Brown, William. 3 pages.

Letter, 10 July 1807, from William Brown, Lynchburg, Virginia, to his father James Brown at Dildawn near Kirkcudbright, Scotland, regarding the Chesapeake-Leopard Affair of 22 June 1807, which he fears may lead to war. Brown comments on his business difficulties, including the murder of his business partner in February, and fires destroying buildings and cargo in April and May. Purchased. (52757)

#### Canada, A. Joseph. .225 cubic feet.

Letters, 1939, 1972-1987, to A. Joseph Canada, Jr. (1939-) of Virginia Beach, Virginia, relating to his work as a member of the Virginia Senate for the 8th District, as well as his involvement in the Republican Party of Virginia and elections at the State and Federal level. Correspondents include, Gerald Baliles (1940-2019), George H. W. Bush (1924-2018), Harry F. Byrd, Jr. (1914-2013), Gerald Ford (1913-2006), Mills Godwin, Jr. (1914-1999), A. Linwood Holton, Jr. (1924-), Richard Nixon (1913-1994), Nancy Reagan (1921-2016), Ronald Reagan (1911-2004), Margaret Thatcher (1925-2013), John W. Warner (1927-2021). ## Clements, Joseph. 8 leaves.

Letters, 28 August and 13 September 1919, from Joseph Clements aboard the USS *Louisville* and at the U.S. Naval Hospital at Hampton Roads, Virginia, to his parents describing the decommissioning of the Louisville and his transfer to the hospital. Letter, 28 August 1919, from Clements to Lucy describes his visit to Paris, France, and the *Louisville*'s decommissioning. Purchased. (52430)

## Cray, Annie Rebecca. 124 leaves.

"Life Along the James: Growing Up in Richmond, Virginia", chronicles Annie Rebecca Cray's (1853-1925) life in Chesterfield and Henrico Counties, and Richmond, Virginia from her birth in 1853 until her marriage to Charles H. Smith (1852-1919) in 1871. Autobiography describes her early life with her parents; moving to her grandparents' farm; her life during the Civil War; her education and social life; and her courtship with Smith. Also includes a brief account of her life after marriage. Gift of Katherine Leary Smith, Edenton, North Carolina; and Richard Leary, Springfield, Illinois. (53292)

## Davis, Anne Turberville Beale. 4 pages.

Letter, 22 December 1856, from Anne Turberville Beale Davis (1809-1884), Hertford County, North Carolina, to her son Wilbur Fisk Davis (1839-1912) at Randolph-Macon College in Mecklenburg County, Virginia, discussing the weather, family news, and Wesleyan Female College. She encourages her son to avoid frivolous social events surrounding the Christmas holiday. Purchased. (52511)

## **Davis, William Roscoe.** 10 leaves and 8 pages.

Papers, 1992, 2018, of the family of William Roscoe Davis (1812-1904) of Hampton, Virginia, consisting of a bibliography, 2018, containing sources about William R. Davis; a family genealogy of Davis's descendants; and an article, "American Album" from Life Magazine (pp. 20-27), 1 June 1992, by Thulani Davis on William R. Journal, 1931-1932, of Frederick William Genz (1902-1994) head chemist of the Richmond Chemical Works (Richmond, Virginia) recording his research on fertilizers and on cleaning compounds, as well as the effect of temperature on materials and the operation of various machines. Purchased. (52691)

#### Hawxhurst, Job. 4 pages.

Letter, 22 December 1869, from Job Hawxhurst (1823-1906) of Fairfax County, Virginia, to his sister Elizabeth Hawxhurst (1830-1922) of Nassau County, New York, regarding the upcoming session of the Virginia legislature, to which he had been elected. He comments on the Virginia Republican party's division over reconstruction of the state. Purchased. (52756)

## Hoopes, A. 3 pages.

Letter, 22 October 1862, from A. Hoopes at the Naval Academy General Hospital in Annapolis, Maryland, to his daughter Edith Hoopes, detailing his capture by Confederate troops at Catlett's Station, Virginia, and his incarceration at Libby and Belle Isle prisons in Richmond, Virginia, including its effects on his health. Paroled, Hoopes states that when he is exchanged, he will return to his unit. Purchased. (52479)

## Howland, Emily. 4 pages.

Letter, 30 March 1897, from Emily Howland, in Northumberland County, Virginia, to Mrs. Leffingwell, noting that Howland visits the Howland Chapel School that she established in Northumberland County for African Americans in 1867 every year. She also discusses the health of their mutual friend Caroline Amelia Comstock (1826-1898) of Ontario County, New York. Purchased. (52536)

#### **Knott, William Baskerville.** 1 volume (71 leaves).

Autobiography, 1975, of William Baskerville Knott (1894-1988) of Dinwiddie County, Virginia, detailing his youth, his naval service in World War I, and his efforts to improve his health after leaving the service. Knott also recounts his travels through the southern United States, including his brief career as a real estate agent in Baldwin County, Alabama. He details his time as a tobacco purchaser and as an insurance salesman, and concludes his account with his career as a farmer. Autobiography includes advertisements, articles, certificates, correspondence, invoices, military records, and photographs. Purchased. (52831)

## Mason, George. 234 leaves, photocopies.

Papers, 1775-1789, of George Mason (1725-1792) consisting of correspondence, drafts of amendments, bills, declarations, and petitions. Papers concern the work of Mason during the Virginia Conventions and his time in the Virginia House of Delegates. Of interest is a copy, by Mason, of the first draft of the Virginia Declaration of Rights, a draft bill for the establishment of a Land Office, and material related to the Mount Vernon Convention, which among other things established navigation rights of shared waterways between Maryland and Virginia. ## Murray, Henry Scott. 4 pages.

Letter, 29 September 1862, from Henry Scott Murray (1836-1905) of Keys Reserve Artillery at Yorktown, Virginia, to his brother John Murray, Jr. (1838-1863) in Delaware County, New York, describing military life at Yorktown, complaining about the poor quality of milk and butter, and decrying soldiers' loss of privileges, including worshipping as they please, because of the work they are required to do. Purchased. (52713)

#### Pastore, Susan Dorr. 1 volume.

Diary, 1 July-9 October 1967, of Susan Dorr Pastore (1951-2018) of Henrico County, Virginia, documenting her social life and her relationship with her boyfriend, including descriptions of dances and concerts attended. Purchased. (52634)

#### Schultz, J. W. 4 pages.

Letter, 7 January 1866, from J. W. Schultz (1824-1908) of Winchester, Virginia, to his aunt Marianna Perry Austin Lindsay (1819-1901) of Greensboro, North Carolina, encouraging her and her family to relocate to the Winchester area. He describes changes to Winchester after the Civil War, including the end of slavery and the establishment of two girls' schools. He comments on a fair to be held in Baltimore, Maryland, to help raise funds to repair the Lutheran church. Purchased. (52755)

## Smith, Robert H. 2 pages.

Petition, 4 October 1864, from Robert H. Smith (1832-1870) of Nelson County, Virginia, to Judge Lucas P. Thompson (1797-1866) of the 11th Judicial Circuit, asking for a writ of habeas corpus for his release from arrest. Smith had been arrested by Lieutenant John A. Carpenter as liable for service in the Confederate army. Smith asserts he is exempt from military service as a justice of the peace. Petition is attested by Thomas M. Dickinson, also a justice of the peace. Purchased. (53224)

## Sanders Family. 2 pages.

Warrant, 12 March 1749/50 (23 March 1750), for Francis Sanders and Daniel Sanders to appear before the Fairfax, Virginia, County Court. Gift of Cathy M. L'Altrelli, Lutherville, Maryland. (52508)

## Stevens, George W. 1 leaf.

Certificate of record, 25 March 1907, of George W. Stevens (1836-1914) of Plymouth County, Massachusetts, detailing his service in Company H, 3rd Regiment Heavy Artillery, during the Civil War. Certificate also provides a brief history of the regiment. Gift of Betsy Brinson, Richmond. (52025)

#### Tilman, John T. 1 leaf.

Letter, 5 May 1862, from John T. Tilman (1845-1905) of Albemarle County, Virginia, to his uncle concerning his uncle's money that Tilman still has. Tilman also notes that troops under Stonewall Jackson (1824-1863) are passing through the area. Purchased. (52565)

#### **Unknown.** 2 leaves and 6 pages.

The Prison Song is a handwritten copy of the lyrics of T"ramp! Tramp! Tramp! (The Prisoner's Hope)" written by George F. Root (1820-1895). Also includes a song sheet containing the words and music by Root. There are a few minor differences between the two sets of lyrics. Purchased. (53251)

## Wood, James. 4 pages.

Letter, 1 October 1832, from James Wood (1790-1846) of Botetourt County, Virginia, to his nephew James Wood (1787-1877) of Pocahontas County, (West) Virginia, detailing news about family and friends in Botetourt County. The uncle informs him that the measles have stricken the family, comments on the late corn crop, and notes that cholera is spreading in the state. Purchased. (53300)

## Witcher, Daniel. 2 pages.

Land grant, 1 September 1857, to Daniel Witcher (ca. 1787-1862) for 125 acres located in Wayne County, (West) Virginia, signed by Governor Henry A. Wise (1806-1876). Purchased. (53309)

## Wrenn, Sol and Virginia. 18.13 cubic feet.

Papers, 1815-2020, of James Solomon Wrenn, Jr. (1921-2020) and Virginia Elizabeth Wimer Wrenn (1921-2017) of Richmond, Virginia, consisting of autograph books, clippings, correspondence, directories, minutes, obituaries, photographs, scrapbooks, and other papers detailing their personal and professional lives and interests and providing insight into their community activities. Papers also include correspondence and other papers relating to members of the extended Wrenn family and the Wimer family. Gift of James Wrenn, Tarboro, North Carolina. (53169)
