Includes a record of births of enslaved persons (1 leaf). Other surnames mentioned: McMahon, Mockbee, Muse, Orgain, Price, Richardson, Shepherd, Thomas, and Wilson. Records, 1 June 2020, containing police body-camera and aerial videos, police audio recordings, use-of-force and other officer narratives, and dispatch reports pertaining to police tear-gassing protesters between 7:00 and 8:00 p.m. on 1 June during demonstrations held at the Robert E. Lee and Jeb Stuart Monuments in Richmond. Also includes list of officers, including rank, present in the vicinity of the two monuments during that time, as well as all Richmond police policies regarding crowd management and use of force that were in effect 1 June 2020. Archer, Fanny T. 3 pages.

Letter, 14 January 1860, from Fanny T. Archer (1800-1877) of Amelia County, Virginia, to her cousin Richard Thompson Archer (1797-1867) of Claiborne County, Mississippi, containing family news, specifically concerning some nieces that are in Mississippi; Richard Archer's candidacy as a delegate to the Mississippi secession convention; and the hire of their aunt's enslaved persons. Cassell, Carter F. 2 pages.

Pay Document for Deceased Soldier, 2 November 1864, for Carter F. Cassell (ca. 1845-1863) of the 50th Virginia Infantry Regiment, Company K, issued by the Treasury Department of the Confederate States of America, Second Auditor's Office in Richmond, Virginia, and addressed to his mother, Catherine Cassell (b. ca. 1825). Payment covered the period from 1 January 1863 to Cassell's death on 5 May 1863. Purchased. (53047)

Cesnola, Luigi Palma di. 1 leaf.

Letter, [4] November 1863, from Luigi Palma di Cesnola (1832-1904) in Libby Prison, Richmond, Virginia, to Captain Thomas P. Turner (1840-1900), commandant of Libby Prison, asking permission to accompany General Neal Dow (1804-1897) to Belle Isle Prison, to distribute blankets and to see Doctor Wolfe before he returns north. He gives his word that only personal family matters will be discussed, adding that his wife is in need of money and would like Doctor Wolfe to relay to her how she may secure funds. Included is a note, 5 November 1863, from Captain Turner informing Cesnola that General John H. Winder (1800-1865) has refused to allow any federal officers to accompany Dow to Belle Isle. Also, a note, 1 December 1863, states that General Winder has removed Dow and appointed Cesnola to distribute the contents of the cases sent by the U.S. Sanitary Commission to Union prisoners. Fretwell, Franklin. 2 pages.

Survey, 15 January 1875, of land owned by Franklin Fretwell (1825-1889) located near New Hope, Augusta County, Virginia. The property was surveyed by L. S. K. McCutchen (1850-1924). Purchased. (52492)

Grennell, George. 4 leaves and 22 pages.

Letter, 3 May 1838, from Congressman George Grennell (1786-1877) of Massachusetts to Congressman Henry A. Wise (1806-1876) concerning the duel between Kentucky Congressman William Graves (1805-1848) and Maine Congressman Jonathan Cilley (1802-1838). Grennell asks Wise to send information to Caleb Sprague Henry (1804-1884) of the *New York Review*, so Henry can write a rebuttal to an article in the *United States Magazine and Democratic Review* that was critical of Wise. Collection includes "The Martyrdom of Cilley" from the *U.S. Magazine and Democratic Review* and a review (probably by Henry) of two published sermons on the duel from the *New York Review*. Herndon, John A. 3 pages.

Letter, 6 June 1864, from John A. Herndon, at Cold Harbor to his brother, Joseph R. Herndon (1834-1912), in Germanton, Stokes County, North Carolina. Herndon relates the ongoing battle at Cold Harbor and how they have had no rest since the 1st of May. He writes of getting plenty of cornbread and bacon and some coffee and how their friend Daniel Keen is doing and that their brother, Ralph C. Herndon (1836-1898) is still teaching at Whitmire. Also included, on the back of this letter is a letter, 3 June 1864 from his father, D. A. Herndon (1803-1888) at Pleasant Gap, relating how everyone back home is fairing. He also writes that he would like to send him some meat, but is not sure that it would reach them under the circumstances. Purchased. (53051)

Lawson, W. T. 4 pages.

Letter, 29 July 1863, from W. T. Lawson (1841-1913) at the camp of Company A, 24 Virginia Regiment, near Culpepper, Virginia, to his brother and sister. Lawson writes of the Battle of Gettysburg, Pennsylvania where all his company were killed or wounded. He specifically mentions the wounding of Lieutenant J. W. Headen, Lieutenant G. W. Kitterman, and Sergeant F. M. Payne. He also expresses the hope that as many of his friends and relations can get out of the "unholy war" as possible, but that he will continue to serve as long as the war lasts. Purchased. (53048)

Maury, Matthew Fontaine. 1 leaf.

Note, 11 October 1856, from Matthew Fontaine Maury (1806-1873), Washington D.C. stating he would be able to deliver a lecture on 4 December at an unidentified lyceum. Purchased. (52974)

McArthur, Emily. 1 volume (20 pages).

Journal, 19 March-29 May 2020, of Emily McArthur describing the early days of the Covid-19 pandemic in Richmond, Virginia. McArthur writes of her feelings of fear and isolation, as well as her loss of employment and changes in her routine caused by pandemic restrictions. Gift of Emily McArthur of Richmond, Virginia. Chemistry in the Civil War, 1963, is a series of radio interviews between David Bidwell Sabine (1902-1997) of Yonkers, New York, and Leo Yanowski (1901-1973) of the "Everybody's Chemistry" radio show on WFUV-FM of Fordham University discussing various aspects of chemistry during the Civil War. Collection also includes an article, 22 February 2014, on Civil War balloonist Thaddeus Lowe (1832-1913), and a funeral bulletin, 25 August 2018, for Sabine's daughter, Mary Sabine Shreve (1935-2018). Letter, 6 January 1829, from Obed Waite (1766-1845) of Winchester, Virginia, to General Roger Jones (1789-1852) of Washington D.C., concerning an enslaved person named Sam Lee who had left Winchester and may be in Washington. Waite also writes about the division of the estate, including enslaved persons, of William Byrd Page (ca. 1772-1812), who was Jones's father-in-law. Purchased. (53228)
