Churchman of England and a company director; Ivan Maltby, chief accountant in the Richmond office; and New York, New York, brokerage firms regarding purchase of stock for Churchman; letters, 1919, from Imperial Tobacco, to agent-buyers and employees in Virginia, and the Carolinas renewing their employment; letter, 22 September 1939, to J. W. Perrin of the Atlantic Coast Line Railroad regarding an unspecified conversation; letter, 29 December 1953, regarding sale of flue-cured scraps; and a list, ca. 1940s, of engineers working for Imperial Tobacco. ### Lantz and Rinker (Shenandoah County, Va.). 1 volume.

Letter, 23 April 1846, from N. M. Martin and Donnans, merchants of Petersburg, Virginia, to Spotswood Burwell (1785-1855) of Granville County, North Carolina, concerning the sale of Burwell's tobacco by the firm. Includes an account of the sale. Purchased. (52415)

# Palmer and Maffett (Loudoun County, Va.). 1 volume.

Account ledger, 1893, of Palmer and Maffett, a merchant firm in Loudoun County, Virginia, recording daily purchases of customers from 23 January to 16 September. # Fowle, Ella H. .175 cubic feet.

Diary, 1850, of Ella H. Fowle (1832-1855) of Alexandria, Virginia, detailing family life and social life in Alexandria, commenting on the weather and on sermons she heard attending services at Christ Church, Alexandria, and elsewhere, and describing trips to Washington D.C., King George and Caroline Counties, Virginia, and Capon Springs, (West) Virginia. Fowle comments on President Zachary Taylor (1784-1850) and his death. Collection includes a transcription of the diary along with a Fowle family genealogy by Wesley E. Pippenger which were published in the *Magazine of Virginia Genealogy* from May 1999 to February 2000.Gift of Beverly Repass Hoch, Wytheville. (53541)

# White, Horace. 3 pages.

Letter, 14 November 1895, from Horace White at *The Evening Post* in New York to R. A. Brock (1839-1914) in Richmond, Virginia. White begins by reminding Brock of his visit to Brock's house in Richmond two years prior seeking information about the gold value of Confederate currency. He then asks Brock if he could send a transcript of the proceedings of the first General Assembly of Virginia in 1619, which he saw at the State Library when he was last in Richmond. In the post script he asks permission to publish Brock's letter in a circular with other testimonials. Purchased. (52481)
