**James River and Kanawha Company (Richmond, Va.).** 2 pages.

Subscribers list, 31 August 1833 and 31 August 1835, for the James River and Kanawha Company, listing the amount of stock and value. Also includes statement, 27 June 1835, of the value of the property of the James River Company being transferred to the James River and Kanawha Company. Purchased. (52502)

Vestry books, 1730-1900, of St. John's Episcopal Church in Richmond, Virginia, containing minutes of the meetings of the vestry as it conducted the business of the church, including calling of ministers; construction and maintenance of church buildings; and financial obligations. ## PERSONAL PAPERS

### **Baldwin, Cornelius C.** 3 pages.

Letter, 17 March 1839, from Cornelius C. Baldwin (1811-1894) in Tuscaloosa, Alabama, to James D. Davidson (1808-1882) in Lexington, Virginia, explaining that he would soon leave for Lexington by horseback, via a southern route through Georgia and the Carolinas as he has business in those states. Baldwin also sends instruction on how to prevent his newspaper, the *Lexington Gazette*, from being suspended and he hopes that his friends in Lexington can help in his absence. Purchased. (52413)

### **Brough, Joseph N.** 2 pages.

Letter, 12 October 1848, from Joseph N. Brough (1811-1884) in Norfolk, Virginia to Henry M. Morfit (1793-1865) in Washington D.C., regarding payment for his grandfather, John N. Davis, who served in the Virginia State Navy during the Revolutionary War. Purchased. (52419)

### **Green, W. S.** .2 cubic feet (9 volumes).

Diaries, 1925, 1938, 1945-1946, 1948, 1950, 1955-1957, of W. S. Green (1886-1961) of Nottoway County, Virginia, detailing the operation of his dairy farm, as well as information on his peach orchards and his tobacco crops. He records the work of himself, his employees, hired help, and German prisoners of war. Green also provides accounts of his work as a teacher and supervisor of agricultural education, and as a member of various farm associations and boards. (53635)

### **Hardenberg, Charles.** .175 cubic feet (314 pages).

"The Hermit of Watt's Island," 1920, written by Charles Hardenberg (1875-1937) of Watt's Island, Accomack County, Virginia, and Jersey City, New Jersey, detailing his twelve years living on Watt's Island, located in the Chesapeake Bay, between Tangier Island and the Eastern Shore. Purchased. (53576)

**Hines, Lottie Louise.** 4 cubic feet.

Papers, 1849-1948, of Lottie Louise Williamson Hines (1875-1940) of Petersburg, Virginia, consisting of applications, articles, correspondence, genealogical charts and notes, postcards, scrapbooks, and other papers documenting Hines' family research for membership in genealogical societies; as well as papers concerning the Colonel John Bannister Chapter of the Daughters of the American Revolution. **Johnson, Bushrod Rust.** 2 pages.

Reports and order, June 1864, of General Bushrod Rust Johnson (1817-1880), near Petersburg, Virginia, consisting of a report, 12 June 1864, to Captain John M. Otey (1839-1883), assistant adjutant general, Department of North Carolina and Southern Virginia, regarding appointments to Johnson's staff; an order, 15 June 1864, to Colonel John S. Fulton (1828-1864), ordering him to march to Petersburg and report to General Henry A. Wise (1806-1876); and a report, 15 June 1864, to Captain Otey stating that he checked the enemy, but lost his old line. Johnson believes this new line better for defense. Purchased. (52965)

**McClanahan, Elijah.** 4 pages.

Letter, 9 March 1829, from Elijah McClanahan (1770-1857) of Salem, Botetourt County (later Roanoke County), Virginia, to J. Draper, Wythe County, Virginia, regarding a freedom suit filed in the Superior Court of Chancery (Wythe County, Virginia) by an enslaved woman named Molly against George Hancock of Botetourt County. McClanahan is attempting to take depositions at Salem and provides information regarding the case. Purchased. (53303)

**Peacocke, T. G.** 1 leaf.

Special order no. 156, 6 July 1864, assigning Captain T. G. Peacocke (b. 1829) of the British Army as a volunteer aide on the staff of General George Pickett (1825-1875). Order is signed by Walter Herron Taylor (1838-1916), assistant adjutant general, Army of Northern Virginia. Purchased. (52966)
