Includes Bible records (6 leaves) and receipt for plot care, Oak Hill Cemetery, Dauphin County, Pennsylvania (1 leaf). Letter, 9 April 1849, from McIlwaine & Brunley of Petersburg, Virginia, to L. H. Kittle (1815-1884) of Henderson, North Carolina, consisting of a list of items purchased by Kittle, including calf skins, coffee, and cotton lines. Purchased. (52416)

Parkman and Newton. 2 pages.

Letter, 3 June 1829, from Parkman and Newton of Norfolk, Virginia, to Samuel Cones of Portsmouth, Virginia, concerning arriving in Hampton Roads, shipping problems from Alexandria, Virginia, and Charleston, South Carolina, and the price of salt in Norfolk. Also mentions he does not know when a ship to City Point, Virginia, will be provided. Purchased. (52418)

Peck, John and Jabez. 2 leaves.

Letter, 1 January 1805, from John and Jabez Peck of Richmond, Virginia, to Herman Hendrick of New York, New York, concerning the shipment of a tin plate and request for a bundle of wire and a box of double tin. Purchased. (52421)

Reynolds, Obadiah J. 1 leaf.

Certificate, 30 March 1854, from the Washington County Mutual Insurance Company of Granville, New York, to Obadiah J. Reynolds (ca. 1808-1884) of Cumberland County, Virginia, certifying payment for insurance on his property. Gift of the Valentine Museum, Richmond. (53963)

Rudolph Family. 2 pages.

Articles of agreement, 1 November 1845, between John, Adam, and Jacob Rudolph of Shenandoah County, Virginia, and William Chauncey of New York, New York, for the Rudolphs to haul and deliver iron ore to the Cedar Creek Furnace in Shenandoah County. Cedar Creek Furnace was owned by Chauncey. Purchased. (53075)

Shields and Sommerville. 2 pages.

Letter, 27 September 1850, from Shields and Sommerville, Richmond, Virginia, to N. O. and C. H. Cram of Portland, Maine, concerning the sale of a planter weighing 168 tons, and the condition of the flour received by the Crams. Also includes discussion of flour and corn prices. Purchased. (52426)

Papers, 1918, of J. A. Sydnor (1860-1934), Federal Food Administrator for Amelia County, Virginia, containing correspondence and forms regarding the rationing of sugar. Records, 2014-2021, of the Friends of Nelson, an organization located in Nelson County, Virginia, documenting western and central Virginia resistance to the Atlantic Coast Pipeline (ACP) project planned by Dominion Energy, Inc., and Duke Energy Corporation. Carter, C. G. 4 leaves.

Letter, 23 April 1945, from C. G. "Jiggs" Carter (1921-1995) of the United States army in Germany to Marguerite Smith Schneider (b. ca. 1921) of Richmond, Virginia, thanking her for sending him her photograph. Carter details the day he and a friend spent with two women in the French countryside, as well as describes a war-devastated Germany. Gift of Adrienne Cummins, Richmond. (53809)

Emery, Edson. 4 pages.

Letter, 14 May 1862, from Edson Emery (1833-1915) of Company E, 2nd Vermont Infantry, in New Kent County, Virginia, to his brother Leonard Emery (1829-1884) of Orange County, Vermont, describing his regiment's movement through New Kent County, commenting on the condition of the Army of the Potomac, and discussing the battle of Williamsburg. Emery also comments about mutual acquaintances. He states that the regiment is camping on the plantation of Robert E. Lee (1807-1870). Purchased. (53063)

Scott, Ella H. 4 pages.

Letter, 28 January 1864, from Ella H. Scott (1830-1912) of Hard Bargain Plantation, Penola, Caroline County, Virginia, to her husband, Lieutenant John W. Scott (1822-1880), a Confederate officer serving with the 30th Virginia Infantry in Richmond, Virginia. Scott writes about running the plantation; the absence of an overseer since William Long left because her father, William Bosher (1789-1884), was unable to pay Long; the different jobs she has assigned to the enslaved women who work in the house; having three enslaved men whipped; the condition of the crops; and taxes. She writes of the marriage of Jimmy Dabney, the education of her daughters, Gay (b. 1853) and Mary (1855-1938), and that their young son, Johnny (1861-1938) has cut his last tooth. She also writes about the upset caused to Lavinia, an enslaved woman, whose son, John, Scott's father wants to take on a trip to act as his errand boy. Other enslaved persons mentioned include Polly, Frank, and Ellen. Purchased. (52698)

Sydnor, A. D. 1 leaf.

Letter, 24 January 1940 [1941?], from A. D. Sydnor (1885-1948) of Amelia County, Virginia, regarding Dr. James L. Hamner (1893-1987) of Amelia County and why a call to military service would adversely impact the rural community Hamner serves. The letter may be 24 January 1941 as the Selective Service and Training Act was not implemented until 16 September 1940. Purchased. (53055)

White, Willie C. 4 pages.

Letter, 14 November 1889, from Willie C. White of Wilmington, Fluvanna County, Virginia, to her aunt, Mrs. Dr. George L. Anderson of Kent Store, Fluvanna County, concerning the death of family and friends, the funny habits of her young son, arranging a visit with her aunt, and discussion of a child named Six who is in the care of her aunt.
