Dinwiddie Family. 4 p.

Allen County, Kentucky, 1853–1973. Bible of Reuben Goodson Dinwiddie (1859–1928) and Phillippa P. Dinwiddie (1853–1946). Other surnames mentioned: Brown, Foster, Graves, Harris, Howard, McReynolds, Overhults, Sexton, Stamps, and Williams. Loaned for duplication by Betty Webb, Henrico. (45525)

Edwards Family. 10 leaves (photocopies) and 1 CD-ROM.

Buckingham and King William Counties, and Richmond, Virginia, 1770–1947. Bible of James Fendall Edwards (1823–1912) and Ann E. Malone Edwards (1839–1882). Includes Bible records (4 leaves), transcript (4 leaves), and a title page (1 leaf) and source notes (1 leaf) provided by the donor, and copy of the same on CD-ROM. According to notes provided by the donor, the birth date of 1770 given for James C. Edwards should actually be 1792. Other surnames mentioned: Gregory and Malone. Gift of Jack C. Includes Bible records (4 p.) and copies of Pleasant Martin's Revolutionary War service record (14 leaves). Other surnames mentioned: McReynolds, Neal, and Preston. Mecklenburg and Southampton Counties, Virginia, 1881–1937. Bible of Nathaniel Mayfield (1886–1974). Bible printed in 1860. Appomattox Iron Works and Supply Company (Petersburg, Va.). 5 cubic feet and 9 volumes.

Records, 1834–1991, of the Appomattox Iron Works and Supply Company of Petersburg, Virginia, including correspondence, customer orders, receipts, credit reports, price sheets and supply catalogs, account ledgers, weekly time books, day book, and cash ledger. Also included are photocopies of diaries of company founder Esek Steere (1831–1908). The collection also contains files relating to the renovation of the company headquarters into a living history museum in the early 1990s. There is artwork, brochures, clippings, genealogical notes on the Armstrong and Steere families, photographs, proposals and specifications, reports, histories, and information relating to tax credits, grants, and urban enterprise zones. Records, 1927–1954, of the Edwards Chevrolet Company, located in Coeburn, Wise County, Virginia, and operated by Conley L. Edwards (1894–1950), Rhex A. Edwards (1924–1966), and Conley L. Edwards, Jr. (1918–1999). Includes an agreement, by-laws, charter, certificates of incorporation, correspondence, financial records, minutes of the stockholders and directors, and stock certificates. Gift of Conley L. Edwards III, Midlothian. (44149)

Records, 1878–1928, of James W. Faulconer (1847–1924) of Orange County, Virginia, relating to his operation of a general store and sawmill, including a daybook, ledger, and memorandum book. Loaned for microfilming by John Y. and Dana S. Faulconer, Orange. (45459)

Graves Mill (Madison County, Va.). .9 cubic feet.

Records, 1784–1886, of Graves Mill, a gristmill located in Madison County, Virginia, and operated by Thomas Graves (1733–1810) and his sons. Includes account books, bonds, correspondence, daybook, ledgers, list of hires, orders for payments or goods, promissory notes, ticket and memorandum book, and other items. Hawkins, P. C. 1 volume (298 p.), photocopies.

Ledger, 1898–1914, of P. C. Hawkins (1861–1951), a funeral director in McGaheysville, Rockingham County, Virginia. The ledger includes customer or decedent's name, and contains accounts for goods and services, such as coffins, embalming, robes, hearse services, and grave lining. Payments made are also noted. In some cases, relationship of customer to decedent is given, as well as place of origin or destination if the body was shipped. There are loose papers at the end, including accounts, receipts, and miscellaneous correspondence. Loaned for copying by Glenn S. Hawkins, McGaheysville. (45522)

Miller's Drug Store (Winchester, Va.). 1 reel of microfilm. (*Misc. Reel 6054*)

Recipe book (or "receipt book"), undated, from the records of Miller's Drug Store in Winchester, Virginia, includes formulas for the treatment of numerous maladies including rheumatism, toothache, shingles, stomach cramps, spitting up of blood, chapped hands and lips, diphtheria, ague, itching, nose bleeds, diarrhea, and burns. The recipes call for the use of a variety of ingredients, including hog's lard, nitric acid, vanilla, iodine, sulphur, and beeswax. Also includes prescriptions for getting rid of freckles, eliminating cockroaches, and keeping flies from pestering horses; formulas for shampoo, hair dye, and lead gold paint; a booklet (*W. M. Niles' Practical Recipe Book*, published in 1852) with recipes for "perfumes, toilet powder, fancy soaps and miscellaneous articles"; and notes on United States and English history. Stonega Coke and Coal Company (Wise County, Va.). 1 volume (103 leaves).

Report on Conferences on Improving Foremanship, Dunbar, Virginia, March 30–April 18, 1925. Report of conferences held in Dunbar, Wise County, Virginia, by the Stonega Coke and Coal Company, in cooperation with the Virginia State Board for Vocational Education, on the jobs of foremen and others who have executive responsibilities in the coal industry. Subjects discussed include job qualifications, types of jobs, accident prevention, quality control, production, leadership, health and sanitation, job satisfaction, and industry cooperation. Akers, Dillard Cundiff. 46 pages.

Papers, 1944–1949, of Dillard Cundiff Akers (1924–1945) of Dublin, Pulaski County, Virginia, who was killed in action in Germany while serving with the 116th Infantry during World War II. The collection includes greeting cards and letters written by Akers to his parents, and telegrams and letters from military personnel notifying his parents that he is missing in action and of his death, the disposition of his personal effects, burial location, funeral arrangements, disinterment and reburial in the United States, and information on his being posthumously awarded the Purple Heart. Allen, W. D. 4 pages.

Letter, 21 February 1877, from W. D. Allen in Washington, D.C., to James Paris of Staunton, Virginia, concerning the 1876 presidential election and the Compromise of 1877, the failure of the Democratic Party, Allen's disregard for the United States' form of government and George Washington (1732–1799), and the end of his plan for settling Canadians in the Shenandoah Valley. Purchased. (45419)

Armistead, Robert A. 83 leaves, photocopies.

Journal, covering the period 14 May 1815 to 5 July 1818, of Robert A. Armistead (1796–1819), a midshipman in the United States Navy, while he was serving aboard various ships in the Mediterranean Sea during the Second Barbary War. This item is a typed transcription of the original. The journal begins with his departure from Sandy Hook, New York, aboard the *USS Constellation*. Armistead describes weather conditions, nautical positions, naval duties performed, sightings and skirmishes with enemy ships, sicknesses and deaths of crew members, and prisoners taken. He also gives descriptions of various places where he was anchored, including Cadiz, Gibraltar, Tunis, Tripoli, Messina, Naples, Syracuse, Marseilles, and Genoa. The journal ends with his return to Sandy Hook aboard the *USS Washington*. Gift of Henry A. Little, Irvington. (45056)

Bill of sale, 23 February 1822, from Zechariah Austin to John Slater, both of New Kent County, Virginia, for a slave named Harriot [Harriett]. Gift of Barbara G. Smith of Catonsville, Maryland. (45534)

Letter, 13 February 1820, from Senator James Barbour (1775–1842) to either the Secretary of War or Navy recommending Edmund W. Cabell of Lynchburg, Virginia, for the position of surgeon's mate in the military. Purchased. (45511)

Barry, William Farquhar. 1 leaf.

Letter, 18 April 1862, from Brigadier General William F. Barry (1818–1879), Chief of Artillery, Army of the Potomac, to Brigadier General Charles S. Hamilton (1822–1891) commanding the 3rd Division, III Corps, informing Hamilton that another battery had been ordered to report to Hamilton's division. Purchased. (45418)

Bevier, Isaac. 7 pages.

Letter, 15 September 1862, from Isaac Bevier of Company E, 44th New York Infantry, to his parents detailing the second battle of Manassas (Bull Run), his wounding, and his stay in the hospital including work as a nurse. He also comments on the campaigning leading up to the battle of Antietam. Also includes a casualty list for the 44th New York. Purchased. (45221)

Boswell, William Ward. .225 cubic feet.

Papers, 1943–2005, of William Ward Boswell (1905–1977) of Arlington, Virginia, relating to his service in the 9th Army Air Force Engineer Command during World War II. Includes identification card, immunization registers, appointment, certificate of service, military service transcript, separation notice, and discharge certificate. There are also letters written by Boswell, and numerous photographs taken by him while he was stationed in England, France, and Germany. Also included is information on the Ninth Air Force Association, including membership materials and newsletters, as well as brochures and clippings on the D-Day invasion of Normandy. Letters, 1862, from George Bouton (ca. 1817–1891) of the 34th Virginia Infantry at Yorktown, Virginia, to his wife, Lucetta Bouton (1819–1893) of Madison County, Virginia, concerning camp life, his personal and business concerns in Madison County, and the beginning of the battle of Yorktown. Purchased. (45424)

Branch, Martha P. 35 pages.

Letters, 1837–1838, from Martha P. Branch (b. 1813) in Amelia County, Virginia, to her husband, Robert Henry Branch (1812–1895), while he was employed in the stagecoach office of James M. Boyd in Richmond. Topics include her concern about his health, church services, news of his former students, marriages in the area, and her

loneliness and feelings about their marriage. Also included in this accession are compositions and math exercises. Purchased. (45568)

Brumfield, James M. 60 pages.

Papers, 1942–1954, of James M. Brumfield (1920–1997) of Waynesboro, Virginia, relating to his service in the United States Navy during World War II. Includes postcards, ration booklet, and a menu and newsletters from the *USS Watts* and the Naval Air Station in Attu, Alaska. There are also histories of the *USS Watts* and *USS Stanly* that were prepared by the Navy Department's Office of Naval Records and History. Gift of Dale Brumfield, Doswell. (45537)

Letter, 16 January 1862, from A. W. G. Davis (1806–1865) of Greenbrier County, (West) Virginia, to Governor John Letcher (1813–1884) introducing Captains George Downs (1820–1899) and John Spriggs of the Moccasin Rangers (later Company A, 19th Virginia Cavalry) with plans for defending what was then western Virginia. Davis also laments the loss of Perry Conley (or Connolly) (1837–1862), the Rangers' commanding officer, killed in action. Purchased. (45507)

Davis, Hawthorne and Loretta. 6 maps (oversize).

Maps, prepared by Hawthorne and Loretta Davis in 2011, of various cemeteries in New Kent and King William Counties, Virginia. Data given includes name, locality, and GPS coordinates of the cemetery, and shows (to scale) the location of named graves, unmarked graves, no-name markers, and trees. Heiskell (1814–1871) in Abingdon, and transcribed by Connally Trigg Litchfield (1829–1909), stating the number of troops that have landed at Fortress Monroe, the imminent arrival of President Jefferson Davis in Richmond, Governor John Letcher's proclamation that any citizens joining the Federal army will be considered traitors, that warships are positioned off of Charleston harbor, and that the secession convention is in secret session. The time of the telegram's arrival in Abingdon is noted at the bottom by Heiskell. Purchased. (45572)

Papers, 1943–1947, 1954, of George Brauning Holcomb (1924–2010) of Woodbury County, Iowa, while he was in the United States Army during World War II, mainly during his enrollment at the Army Specialized Training Program at the University
