Barksdale Family. 10 leaves.

Charlotte County and Richmond, Virginia, 1738–1936. Bible of Claiborne Barksdale (1816–1883). Bible printed in 1839. Includes Bible records (6 leaves) and photographs (4 leaves, copies of the front and back of two photographs). Other surnames mentioned: Bouldin and Read. Loaned for duplication by Panny Rhodes, Richmond. (50393)

Bradshaw Family. 3 leaves.

Petersburg and Richmond, Virginia, 1867–2003. Bible of P. Ernest Bradshaw (1867–1950) and Nannie Malone Bradshaw (1867–1924). Other surname mentioned: Malone. Loaned for duplication by Ann Malone Bradshaw Eley, Richmond. (50408)

Curtis Family. 70 leaves and 20 p.

Warwick and York Counties, and Newport News, Virginia, 1791–1966. Bible of John L. Curtis (d. 1905) and Virginia Garrow Curtis (d. 1930). Includes Bible records (6 leaves), unidentified photographs from the “Family Portraits” section of the Bible (4 leaves), and enclosures (ca. 60 leaves and 20 p.) from this Bible and another family Bible (which contains no information on the family record pages) given with this donation. Enclosures include genealogical notes on the Curtis and related families, chiefly the Cary and Harwood families; and school grade level promotion certificates for Wray Lee Curtis. Other surnames mentioned: Fauntleroy, Garrow, Mapp, Powell, and Williamson. Gift of Carrie Wray Curtis, Grafton. (50342)

Hannon Family. 3 leaves.

Petersburg and Richmond, and Sussex County, Virginia; and Maryland and North Carolina, 1923–1993. Bible of Alvin J. Hannon (1927–1995) and Ernestine Charity Hannon (1923–2005). Other surnames mentioned: Charity, Price, and Sparks. Gift of Frances R. Costin De Jan, Richmond. (50390)

Harris-Meador Family. 60 leaves.

Buckingham and Scott Counties, and Farmville, Norfolk, Richmond, and Staunton, Virginia, 1844–1956. Bible of Samuel David Harris (1894–1954) and Virginia Meador Harris (1891–1968). Bible printed in 1913. Includes Bible records (4 leaves) and enclosures (56 leaves). Enclosures consist chiefly of family photographs, genealogical information, newspaper clippings, and correspondence. Other surnames

mentioned: Beninghove, Ellington, Morton, Moss, Warren, and Whitlow. Loaned for duplication by George B. Ellington, III, Richmond. (50355)

Landes Family. 3 leaves.

Augusta County, Virginia, 1897–1963. Bible of C. R. Landes (d. 1926) and Laura E. Landes (d. 1963). Bible copyright date 1891. Other surnames mentioned: Baker, Bogers, Good, Hunter, and Lawman. Gift of Tracy Hunter, Richmond. (50377)

Pauley Family. 4 p.

Bland and Giles Counties, Virginia, 1763–1870. Bible of Hiram A. Pauley (b. 1801) and Ann B. Pauley (b. 1817). The top third of one sheet has been ripped off, resulting in a loss of information on two pages. This record was found in the pages of another Pauley family Bible (Accession 50340). Gift of Frank Pace, Vineland, New Jersey. (50341)

Pauley Family. 6 leaves.

Bland and Giles Counties, Virginia; and California, New York, and North Dakota, 1842–1933. Bible of Addison B. Pauley (1846–1927) and Minnie C. Henderson Pauley (1842–1900). The cover of the Bible is embossed with the names Isiah and Naomi Bruce. Other surnames mentioned: Alexander, Bogle, Dopp, Duffy, Henderson, Schillings, and Tease. Gift of Frank Pace, Vineland, New Jersey. (50340)

Roach Family. 6 leaves.

Bland County, Virginia; and West Virginia, 1837–1910. Bible of John P. Roach (1837–1909) and Louisa V. Pauley Roach (1851–1910). Other surname mentioned: Pauley. Gift of Frank Pace, Vineland, New Jersey. (50339)

Smith Family. 4 leaves.

Rockingham County, Virginia; and Georgia, 1792–1895. Bible of William C. Smith (1808–1895) and Eliza Lofland Smith. Bible printed in 1722. Other surnames mentioned: Lofland and Peal. Transferred from Local Records Services, The Library of Virginia, Richmond. (50372)

Wilkes-Duncan Family. 12 leaves.

Albemarle, Charlotte, and Nottoway Counties, Virginia, 1805–1941. Bible of Jacob Agee Duncan (1805–1896) and Eliza M. Wilkes Duncan (1811–1889). Includes Bible records (3 leaves); obituaries for Colonel Garnett Duncan and Henry F. Glidewell (1 leaf); a photograph of Jacob Agee Duncan with inscription on reverse (2 leaves); receipts (3 leaves); and a letter, 1 October 1861, from James H. Duncan to his parents, Mr. and Mrs. Jacob A. Duncan (3 leaves). The Duncan surname is sometimes spelled Dunkin. Other surnames mentioned: Fore, Glidewell, and Tucker. Loaned for duplication by Ann Malone Bradshaw Eley, Richmond. (50407)

Account book, 1811–1822, of Thomas Adams (1779–1865) of Caroline County, Virginia, containing accounts for making and repairing shoes. The date, customer name, type of service, cost, and amounts paid are recorded. Occasionally, the type of shoe is also noted. Purchased. (50373)

Finley, Samuel. 1 volume (174 pages).

Account book, 1795–1815, of Samuel Finley (1775–1849), a merchant in Greenville, Augusta County, Virginia. The volume contains receipts for money paid to various individuals, lists of notes due to Finley, store accounts, and accounts for farm labor and for cattle bought and sold. Purchased. (50378)

Elko Union Church (Sandston, Va.). 29 leaves, photocopies.

A record of various important dates, 1909–1955, in the history of Elko Union Church, Sandston, Virginia, some of which were retrospectively recorded after a fire destroyed original records in 1922. Includes date of the church's dedication, names of charter members, names of pastors and officers, and minutes of various meetings and revivals. GENEALOGICAL NOTES AND CHARTS

Pinder-Pindar Family. 1 vol. (82 p.)

Notes. *Pinder (Pindar) Family Origins in Bermuda, the Bahamas, and in Barbados: A Working Hypothesis.* Provides information on various early Pinder (sometimes spelled Pindar) lines in Bermuda, the Bahamas, Barbados, and the Southern United States, chiefly the assumed descendants of Timothy Pinder (1609–ca. 1680) of London, England, and Bermuda, with information on lines that settled in North Carolina, the Bahamas, and Barbados. Also examines a handful of individuals with the Pinder-Pindar name appearing in records of Gloucester County, Virginia; Georgia; and Westmoreland County, England. Compiled by the donor in 2011. Yancey Family. 59 p.

Notes. Includes information on the descendants of Charles Yancey (b. 1766) through his son Joel Yancey (1796–1865) and grandson John Hampton Yancey (1830–1915), including lines that settled in Albemarle County and Richmond, Virginia; Braxton County, (West) Virginia; and Florida, Kentucky, Missouri, Ohio, and Wisconsin. Other surnames mentioned include: Alexander, Brown, Burriss, and Field. Notes are split into three separate reports: “Charles Yancey of Albemarle;” “Joel and Elizabeth Yancey of Albemarle and Braxton Counties, 1796–1888;” and “John Hampton Yancey and Susan Mary (Burriss) Yancey, 1830–1926.” Reports include copies of Bible records, correspondence, indentures, newspaper articles, and photographs. PERSONAL PAPERS

Adams, Cary Young. 23.7 cubic feet.

Papers, 1988–2006, of Cary Young Adams (b. 1927) of Norfolk, Virginia, containing genealogical research files on the Cary, Chisman, Curtis, Harwood, Hill, Hubbard, Hughes, Jones, Lee, Mallicote, Moss, Perkins, Whitaker, Wills, Wynne, and Young families. Adams' research interests were on these families who settled in Charles City, Dinwiddie, Elizabeth City, Gloucester, Isle of Wight, James City, Nansemond, Norfolk, Southampton, Warwick, and York Counties, Virginia; North Carolina; and England. The collection contains Bible records, book catalogs, brochures, guides, and indexes to records in various institutions, census records, citations, queries, and surname exchange information from various genealogical websites, clippings, correspondence, genealogical charts, genealogical and hereditary society applications and other materials, maps, military and pension records, newsletters, obituaries, passenger lists, photographs, published sources, tax records, tombstone inscriptions, and vital statistics. Banister, John. 3 leaves.

Papers, 1835, of John Banister (1815–1835) consist of two photographs of his grave marker, located in the Cemitorio Dos Ingleses, Gamboa, Rio De Janeiro, Brazil, and a transcript of the text on the marker. Banister, a midshipman in the United States Navy, died in Rio De Janeiro on 3 June 1835 while attached to the U. S. Sloop of War *Natchez*. Photographs taken in 2011. Papers, 1881–1890, of William M. Barnum (1856–1926) of New York City, while he was serving as president of the Henrico Coal Company and the Kanawha Improvement Company, including a letter book and two minute books. Purchased. (50370)

Crofut-Humiston Family. 27 pages.

Papers, 1855–1862, of the Crofut and Humiston families of Broome County, New York, including an account, correspondence, and poetry. Most of the collection consists

of letters written by Charles K. Crofut (ca. 1838–1862) to his sister Almira Crofut (1832–1915), while he was serving with the 89th New York Infantry on Roanoke Island, North Carolina, and also in Washington, D.C. and near Harpers Ferry. Topics include health, impending battles, marches, duration of the war and his confidence in victory, pay, rations, and supplies. Crofut also writes about the collision of the steamers *West Point* and *George Peabody* on 13 August 1862, and his regiment's heavy fighting at the Battle of Sharpsburg. Gift of Dr. David L. and Gwynne R. Litchfield, Bruington. (50400)

Croll, Donald E. 183 pages and 3 photographs.

Papers, 1942–1945, of Donald E. Croll (1920–2004) of Richmond, Virginia, while he was serving with the 259th Ordnance Medium Maintenance Company in the Philippines during World War II. Includes correspondence, essays, and verses regarding his wartime experiences, language lessons, and photographs. Gift of Charlotte O. Croll, Richmond. (50364)

Dashiell, Segar Cofer. 12 reels of microfilm. (*Misc. reel 6082–6093*)

Papers, 1768–1989, of Segar Cofer Dashiell (1901–2001) of Smithfield, Virginia, containing information on the history of Smithfield and Isle of Wight County. The papers include abstracts of county court records, book drafts, clippings, genealogical notes, published histories, Smithfield town lot ownership information, scrapbooks, and other materials. Lent for microfilming by the Isle of Wight County Museum, Smithfield. (50200)

Davis Family. .1 cubic feet.

Papers, 1835–1863, of the Davis family of Philadelphia, Pennsylvania, including correspondence, poetry, and clippings. The majority of the collection consists of letters written by Robert G. Davis (1838–1880), to his parents and siblings, while he was serving with the 28th Pennsylvania Infantry in Fauquier and Loudoun Counties, Virginia, and in Maryland. Gift of Dr. David L. and Gwynne R. Litchfield, Bruington. (50399)

Easterly, Harry W., Jr. 7.5 cubic feet.

Papers, 1942–2003, of Harry W. Easterly, Jr. (1922–2005) of Richmond, Virginia, including his research on the Westham area of Richmond, and also on George Minefee (ca. 1595–1645) of England, and James City and Charles City Counties, Virginia. The collection also contains personal files, mostly relating to his avid interest in golf. Gift of Mary B. Easterly, Richmond. (42103)

Henkel, Siram Peter. 9 volumes.

Journals, 29 April 1842–14 January 1878, of Siram Peter Henkel (1809–1878) of Plains Mill, Rockingham County, Virginia. There are nine journals, numbered 8 to 16. Most of the entries relate to Henkel's farming, milling, and sawing activities, most of which were undertaken by hired labor or "hands." Other subjects include attending church services, marriages and deaths of family and friends, social activities, politics, and Civil War skirmishes and battles near his property. The last volume ends shortly after Henkel's Plains Mill property was severely damaged by a flood. Purchased. (50109)

Jessee Family. .675 cubic feet.

Papers, 1915–2006, of Ora Stanford Jessee (1884–1954) and Martha Viers Jessee (1892–1968) of Russell County, Virginia, including agreements and contracts, clippings, correspondence, discharge papers and separation notices, greeting cards, invitations and announcements, photographs, recipes, and other items. The majority of the collection consists of letters written to them by their sons Ralph Stanford Jessee (1918–1999), Carroll Lee Jessee (1921–1978), and Arthur Dance Jessee (1922–2006), while they were serving in the military during World War II. Johnston, F. Claiborne, Jr. 1 vol. (163 p.)

A More Complete Record of Those Who Perished in the Richmond Theater Fire, December 26, 1811, compiled by F. Claiborne Johnston, Jr., in 2011, seeks to provide as full and accurate a list of the individuals who died as a result of the fire as can be determined and, where possible, to give some family context for each of the victims. Gift of F. Claiborne Johnston, Jr., Richmond. (50107)

Account book, 1817–1824, kept by Joseph Jones (1749–1824) as collector of customs at the port of Petersburg. The accounts include date, name, and amount collected. Purchased. (50405)

Kern, Margaret Ethel Kelley. 8.5 cubic feet.

Papers, 1895–1949, of Margaret Ethel Kelley Kern (1874–1975) of Richmond, Virginia, relating to her work with various patriotic and relief organizations during World War I, including the National League for Women’s Service, Godmother’s League, War Camp Community Service, and the Service Legion, focusing especially on her work at the hospitals at Camp Lee and the U.S. Army Debarkation Hospital No. 52 at Richmond College. There is also information regarding her involvement in the Powhatan Hill Memorial Association, Thomas Jefferson National Memorial Association, and the United Daughters of the Confederacy. The collection contains articles, constitutions and by-laws, commissions, correspondence, greeting cards, guidebooks, invitations, lists, magazines, newsletters, notebooks, pamphlets, photographs, postcards, posters, publications, reports, and scrapbooks. Painter, Joseph Crockett. 127 leaves.

Pastoral register, 1873–1917, of Joseph Crockett Painter (1845–1919), a Presbyterian minister who over the course of his career led churches in Fredericksburg, and Albemarle, Culpeper, Orange, and Rockingham Counties, Virginia. The majority of the register lists sermons preached by Painter from 1875–1911, including the Bible passage used, the subject of the sermon, when and where it was preached, number of times preached, whether written or extemporaneous, size of the congregation, and remarks. Sermons dated 1875–1884 are found in the “Register of Sermons” section of the book; the rest, 1884–1911, are scattered across unused pages of other sections. The used pages of those other sections record baptisms, 1874–1890; communicants received,

1873–1890; marriages, 1874–1917; funerals, 1874–1890; and pastoral visits, 1877. Enclosures include newspaper clippings, two handwritten copies of the text for a wedding service, notes for a sermon, and a copy of the 26 February 1893 resolution adopted by Cooks Creek Church upon Painter’s resignation of its pastorate. Raymond, Douglas J. 1 vol. (30 p.)

Diary, 4-24 June 1944, kept by Douglas J. Raymond (1921–1994) of Rosemont-LaPetite-Patrie, Quebec, Canada, while serving aboard the Royal Canadian Navy destroyer HMCS *Saskatchewan* off the coast of France at the time of the D-Day invasion. The narrative runs from 4 June, when Raymond’s ship is at work “cleaning out German subs” in the English Channel; to bombardment of German positions along the French coast and protecting Allied invaders from enemy aircraft and submarines on 6 June; continued action in the Channel until docking in Plymouth, England, on 11 June for refueling and repairs; taking part in a “surprise attack” in the Channel, about 100 miles from the invasion site, 23 June; to the final entry, “still battling subs. (Im [sic] fed up),” on 24 June. Raymond later became a citizen of the United States and resided in New Kent County, Virginia. Gift of Mary Raymond, Rockville. (50043)
