Lee writes to decline an offer of assistance from the recipient, who served under her husband, Robert E. Lee (1807-1870), during the war. She hopes that they will be able to secure a good photograph of her husband, and that she thinks those by Julian Vannerson are the best. In a postscript, she asks that her letter not be printed since her husband dislikes notoriety either for himself or for his wife. Purchased. (52874)

Morgan, David W. 2 leaves and 3 pages.

Letter, 14 May 1847, from David W. Morgan, Captain Smith P. Bankhead's Company, 1st Regiment, Virginia Volunteers, at China, Mexico, to William A. Smith (1830-1915) of South Hadley, Massachusetts, regarding Morgan's service in the company during the Mexican War. Morgan describes casualties along their route, mentions the battle of Puente Nacional or National Bridge, and comments on the weather and conditions at China. Includes a transcript of the letter. Gift of Karl F. Miller, Philadelphia, Pennsylvania. (53629)

Roberts, F. B. 2 leaves.

Circular letters, 14 May-4 June 1907, from F. B. Roberts of Chase City, Virginia, to the constituents of the 25th State Senate District of Virginia, which then encompassed Mecklenburg and Brunswick Counties. Roberts writes of his intention to run for re-election for the Senate and lists his accomplishments during the previous General Assembly session. He also writes at length of his view that the 25th District seat should alternate between someone from Mecklenburg County and Brunswick County. Purchased. (52967)

Stannard, Dwight W. 3 pages.

Letter, 13 August 1864, to Dwight W. Stannard in Oneida County, New York, from a Union soldier named Cuff at the camp of Company A, 97th New York Infantry Regiment, near Petersburg, Virginia. He relates the events of the Union planned explosion and subsequent Battle of the Crater in Petersburg. He also disparages the African American troops present at the battle. Purchased. (52871)

Unidentified. 4 pages.

Letter, 18 December 1862, from a Union soldier named Andrew at Fort Scott, Virginia, to his wife Sarah. He writes that his only pleasure is when writing to his wife or reading letters from her. He also writes at length of his displeasure at the command of General Ambrose Burnside, days after the Union defeat at the Battle of Fredericksburg, and he hopes that General George McClellan, who he deems a superior commander, will again be put in command.
