Papers, 1903-1963, of George Edward Bates (1874-1955) of Philadelphia and Scranton, Pennsylvania, and Albany, New York, concerning a lot he owned in the East Fairmount neighborhood in Norfolk County, Virginia. Papers also include correspondence regarding the maintenance of his parents' graves in Calvary Episcopal Church in Delaware County, Pennsylvania, and George Bates' retirement from the Delaware and Hudson Railway Company. Letter, 19 July 1932, from George S. Bernard in Petersburg, Virginia, to his wife, Mary Bernard (1883-1963). Bernard writes of various vacations taken by family members, including a three-hundred-and-fifty-mile trip by car. He also writes of friends and family planning to visit at the weekend and apologizes for making his wife mad earlier in the week. Purchased. (53010)

Brown, Walter S. .175 cubic feet.

Journals, 1896-1903, of Walter S. Brown (1874-1955) of Highland County and Richmond, Virginia; and New Hampshire, detailing his life as a member of the Christian Crusaders and as an itinerant minister in Highland, Nottoway and other Virginia counties and Richmond; as well as Pendleton County, West Virginia; Massachusetts; and New Hampshire. Brown describes prayer meetings, revivals, and worship services; as well as his personal religious journey. Collection includes correspondence, broadsides, and related documents. Purchased. (53752)

Chiles, Fannie D. 1 leaf.

Letter, 31 October 1935, to Fannie D. Chiles in Richmond, Virginia, from J. S. DeJarnette (1866-1957), Superintendent of Western State Hospital in Staunton, Virginia. DeJarnette writes regarding Chiles' daughter, Dora Mullins (1895-1960), who is doing well and that he is willing to release her with the understanding that she can return to Western State should she need. He relates the patient's desire to go home, but if this is too near her divorced husband, then she should remain in the hospital. Purchased. (53018)

Cuthbert, Charles Henry. .225 cubic feet.

Papers, 1976-1991, of Charles H. Cuthbert (1917-2004), member of the Petersburg, Virginia, city council, consisting of articles, clippings, correspondence, minutes, prospectuses, reports, speeches, and other documents relating to historical structures and to historical reenactments in Petersburg. Papers also includes reminiscences of members of the Gresham family of Dinwiddie County and Petersburg. Gift of Charles H. Cuthbert, Jr., Petersburg. (51361)

Letters, 1860-1865, from Lieutenant A. W. Edwards (ca. 1835-1865) of Company C, 15th Virginia Cavalry, to his wife Ann Virginia Edwards (1834-1904) in Princess Anne County, Virginia, detailing his military activities during the war, providing news of friends in the company, and hoping for a Confederate victory in the war. Also includes correspondence between husband and wife after Edwards' capture at the battle of Spotsylvania, as well as correspondence regarding Edwards' death. Letter, 13 September 1860, from John Fletcher (1836-1862) of Fauquier County, Virginia, to Hamilton L. Gibson (1816-1881) of Frederick County, Virginia, declining to purchase an enslaved woman named Susan. Includes biographical information on Fletcher. Purchased. (53222)

Hart, Nancy Pretlow Bozarth. .225 cubic feet.

Papers, 1952-1958, of Nancy Pretlow Bozarth Hart (1927-2016) of Richmond, Virginia, detailing her term as president of the Sterlingwood Woman's Club of Richmond. Papers contain clippings, histories, lists, notes, programs, reports, scrapbooks, and yearbooks. Papers also include two magazines, 1954-1955, containing articles regarding the Virginia Museum of Fine Arts' artmobile. Gift of Lyndon H. Hart, III, Richmond. (51435)

Letter, 1 February 1942, from Grace Heiston in Rileyville, Page County, Virginia, to her son, Joseph Heiston (1920-1968) at Fort Eustis, Virginia. Heiston thanks her son for a money order and medicine which he sent her and asks how he likes the camp. She also writes that his sister, Eva (1923-2011) is to marry Bill Atkins (1922-1981) and that she feels it is for the best because she worries about girls, especially during a time of war. Purchased. Kagey, David F. 1 leaf and 3 pages.

Letter, 25 June 1863, from David F. Kagey (1834-1923) of Captain Rice's Artillery Company in Maryland to Mary F. Kagey (1832-1911) of Shenandoah County, Virginia, detailing the Confederate army's move into Maryland and Pennsylvania. He provides the general locations of the army's corps, notes the difficulty of buying anything in Union territory, and adds that three captured African Americans have been sent south. Purchased. Moss, Thomas Overton. .175 cubic feet.

Papers, 1917-1918, of Thomas Overton Moss (1893-1939) of Richmond, Virginia, consisting of letters of recommendation, 1917-1918, for Moss as an officer in the United States Navy Reserve and to be assistant paymaster aboard the USS Middlesex; correspondence with Harry F. Byrd (1887-1966) regarding politics and Byrd's governorship; correspondence, 1925-1928, regarding Moss's service in the Officer Reserve Corps and state and local politics; and related papers. Letter, 7 October 1935, from Charles S. Smith Jr. in Saluda, Middlesex County, Virginia, to his son, Charles S. Smith III (1916-1993) at Lynchburg College, Lynchburg, Virginia. Smith writes that they have enjoyed their son's letters and glad that he received a quiet room in his second year in college. He also writes of the death of John Stubbs (1871-1935) and Charles Hoskins (1865-1935). He closes by saying that they should be moving into their new house by November and how much he likes his Terraplane automobile. Purchased. (53015)

Letter, 10 May 1870, from an unidentified correspondent in Richmond, Virginia, to "Lizzie" providing news of the Capitol Disaster of 27 April 1870 when the third floor courtroom balcony collapsed during arguments before the Virginia Supreme Court of Appeals regarding the Richmond mayoral election. The letter provides news of the deaths of neighbors who were among the over 60 persons killed. Purchased. (53866)

Genealogical materials collected by Jean Von Schilling of Richmond, Virginia, containing information on the Brent, Newman, Phillips, Wade, Wills, Winder, and Wynne families of Fauquier, James City, and York Counties, Virginia.
